USE OF RAMPS – ALL BREEDS

The following breeds **must be judged on a ramp** through all levels of conformation competition: Lagotto Romagnolo, Clumber Spaniels, English Springer Spaniels, Sussex Spaniels, Basset Hounds, Cirneco dell'Etnas, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden and Spanish Water Dog. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. Ramps can be used to judge any breed in an emergency situation where use of a ramp is not indicated in the premium list; an exhibitor has the option of withdrawing their entry and receiving a refund.
