#### DIRECTIONS TO THE TRIAL

**NORTHBOUND ON I-5:** Take exit 194 toward Snohomish/Wenatchee onto US-2 E (Cascade Loop). Go for 2.3 mi.  
Take the left exit toward Lake Stevens onto WA-204 E (State Route 204). Go for 2.4 mi.  
Continue on WA-204. Go for 0.3 mi.  
Take the 3rd exit from roundabout onto WA-9 N. Go for 0.1 mi.  
Take the 2nd exit from roundabout onto WA-9 N. Go for 3.4 mi.  
Continue on WA-9. Go for 1.3 mi.  
Take the 1st exit from roundabout onto 84th St NE toward Granite Falls/84th St NE. Go for 0.6 mi.  
Turn left onto 99th Ave NE. Go for 0.6 mi.  
Turn left. Go for 0.2 mi. End at **Country Classic Kennel Training** 9332 99th Ave NE, Arlington, WA 98223

- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the On-Site Secretary is notified no later than one half hour prior to the start of the first class in the trial, the Clubs is required to refund the entry fee. Note: No fee is paid to the AKC for females in season who are withdrawn.

#### TRANSFER OF ENTRIES

**NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON TUESDAY, SEPTEMBER 2. AFTER THIS TIME, YOU MUST CONTACT THE ON-SITE SECRETARY.**

**OBEDIENCE OR RALLY:** A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit.
