

### NEW EXHIBITOR BRIEFING

Superintendent will have New Exhibitor Handbooks available, and are there to answer any of your questions on the days of the trials.

### Females in season are not permitted to compete.

If a female is withdrawn from competition because it came into season and the event superintendent is notified no later than one half hour prior to the start of the first class in the trial, the club is required to refund the entry fee. WSOTC will retain a \$5.00 administrative fee per event for each bitch withdrawn. Obedience and Rally are separate events. If bitch is entered in more than one class in the same event on the same day, \$5.00 will be the total amount withheld. If bitch is entered in one event both days, total fee will be \$10. If bitch is entered in two events both days, total fee will be \$20.00.

## PLEASE NOTE

WSOTC recognizes the privilege clubs are given to host their trials at private event centers. We contractually agree to uphold the regulations of these sites. Unfortunately, Fun Fur Paws has experienced ongoing site issues and has enacted enforcement policies of their regulations. In this effort, please note the below regulations that will be in full effect and enforced by both the event site management, WSOTC Trial Committee, WSOTC Board, and any witnessing WSOTC club members and exhibitors. We respectfully ask that all exhibitors uphold these regulations in an effort to maintain a safe and fun trial for all, as well as preserving our access to these facilities. Failure to do so may result in exhibitor being excused from trials, without refund, and possible ban from event site per event management's discretion.

### Fun Fur Paws DOES NOT ALLOW:

- Speeding on any portion of the property is prohibited. No exception. Speed limit is a posted maximum 5 mph and is enforced by camera.
- Aggressive dog behavior is prohibited on show grounds. This includes the open fields, between buildings, parking lot, fence fighting, and jumping fences to challenge other dogs or people. Running dogs off leash is a privilege, not a right. Please have control of your dog(s) at all times. If unsure, keep 'em leashed. Dogs must be on leash at all times, unless otherwise posted.
- Pick up after your dog on all parts of the property. Poop is being left in the large fields. If you get distracted, please take the time before leaving the area or open fields, to do a walk around. Leaving poo is so uncool, says every shoe.
- Glass bottles are prohibited inside the facility. No exceptions.
- Smoking/vaping is not permitted on any part of fun fur paws' property, except inside personal vehicle. Cigarettes must be discarded in personal vehicle and not in any fun fur paws' trash.

## TRANSFER OF ENTRIES

**NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON MONDAY, MARCH 23, 2026. AFTER THIS TIME, YOU MUST CONTACT THE SUPERINTENDENT ON SITE.**

**OBEDIENCE OR RALLY:** A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. For Bitches in Season, refer to General Rules in Premium List. Written transfer application must be submitted to the Superintendent at least 30 minutes prior to the start of the trial, not 30 minutes prior to the start of the class.
