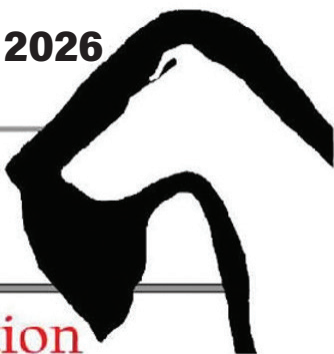

This is a clean up after your own dog show. Doggie Bags & buckets to dispose of the used doggie bags will be provided. We request you tie the top of the used doggie bag. Doggie bags will be available throughout the grounds, at the club table, & at the rings. No poop scoops will be available.

Automated External Defibrillator (AED): Two Defibrillators at the fairgrounds. One located in Cascade Hall (Obedience building) In the hall across from the Business Office of the Fairgrounds. The club defibrillator will be at the Club table in Douglas Hall (Conformation Building). If there is an incident needing a defibrillator come and get one and have someone nearby call 911 and give the location of the of the person needing emergency care.
