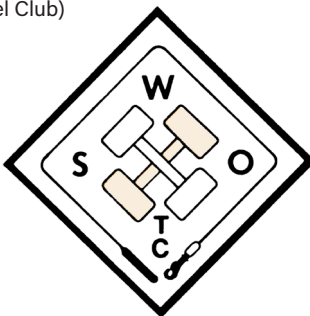

ROUTES TO THE SHOW

FROM THE NORTH OR SOUTH ON I-5 - Take the Auburn Exit (Hwy 18). Go to Auburn and take the Enumclaw Exit to Highway 164. Follow the signs to Enumclaw (Highway 410), just before Enumclaw, turn right on 244th, go to 456th and turn left. It becomes Warner. Stay on Warner to the fairgrounds.

GOING SOUTH ON I-405 OR COMING FROM THE RENTON AREA - Go east on Maple Valley Highway (Highway 169), go through Black Diamond, continue on until 416th SE, turn left, then follow signs to the fairgrounds.

OBEDIENCE & RALLY TRANSFERS WILL BE ACCEPTED FOR THESE TRIALS ACCORDING TO CH. 1, SEC. 16a, OBEDIENCE REGULATIONS.

Written transfer application must be submitted to the Superintendent at least 30 minutes prior to the start of the trial, not 30 minutes prior to the start of the class.

OBEDIENCE REGULATIONS - CH.1, SEC. 14

BITCHES IN SEASON

Females in season are not permitted to compete.

If a female is withdrawn from competition because it came into season and the event superintendent is notified no later than one half hour prior to the start of the first class in the trial, the club is required to refund the entry fee. WSOTC will retain a \$5.00 administrative fee per event for each bitch withdrawn. Obedience and Rally are separate events. If bitch is entered in more than one class in the same event on the same day, \$5.00 will be the total amount withheld. If bitch is entered in one event both days, total fee will be \$10. If bitch is entered in two events both days, total fee will be \$20.00.

Effective April 1, 2021, new Obedience pilot program, **Fix n' Go**, was introduced.

TRANSFER OF ENTRIES

NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON WEDNESDAY, AUGUST 10. AFTER THIS TIME, YOU MUST CONTACT THE SUPERINTENDENT ON SITE.

OBEDIENCE OR RALLY: A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit.
