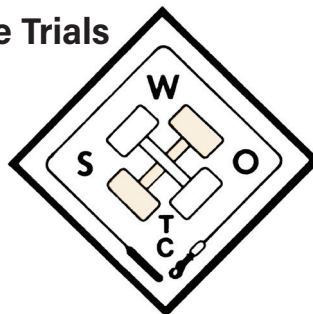

ROUTES TO THE SHOW

Directions to Country Classic Kennels

- Take Exit 199 off I-5 in Marysville. Go east for about 3.5 miles to the light at Hwy 9. Turn left (north) onto Hwy 9.
- Go 1.3 miles to the roundabout. Take the first exit onto 84th St NE.
- Go 0.6 miles to the light at 99th Ave NE. Turn left.
- Go 0.6 miles. Turn left at the Country Classic sign and drive to the end of the driveway.

OBEDIENCE REGULATIONS - BITCHES IN SEASON

Females in season are not permitted to compete.

If a female is withdrawn from competition because it came into season and the event superintendent is notified no later than one half hour prior to the start of the first class in the trial, the club is required to refund the entry fee. WSOTC will retain a \$5.00 administrative fee per event for each bitch withdrawn. Obedience and Rally are separate events. If bitch is entered in more than one class in the same event on the same day, \$5.00 will be the total amount withheld. If bitch is entered in one event both days, total fee will be \$10. If bitch is entered in two events both days, total fee will be \$20.00.

OBEDIENCE & RALLY TRANSFERS WILL BE ACCEPTED FOR THESE TRIALS ACCORDING TO CH. 1, SEC. 16a, OBEDIENCE REGULATIONS.

Written transfer application must be submitted to the Superintendent at least 30 minutes prior to the start of the trial, not 30 minutes prior to the start of the class.

TRANSFER OF ENTRIES

NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON TUESDAY, AUGUST 4. AFTER THIS TIME, YOU MUST CONTACT THE SUPERINTENDENT ON SITE.

OBEDIENCE OR RALLY: A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. For Bitches in Season, refer to General Rules in Premium List.

Due to limited space there will be NO INDOOR CRATING allowed with the exception for trial workers and disabled exhibitors. Pop-up canopies may be set up on the lawn outside the building. **Crating tents will be provided outdoors.**
