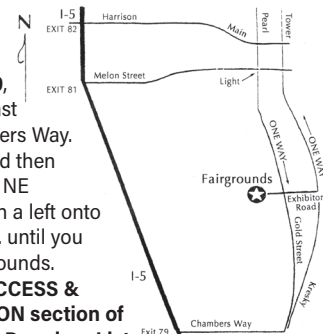


ROUTES TO THE SHOW
