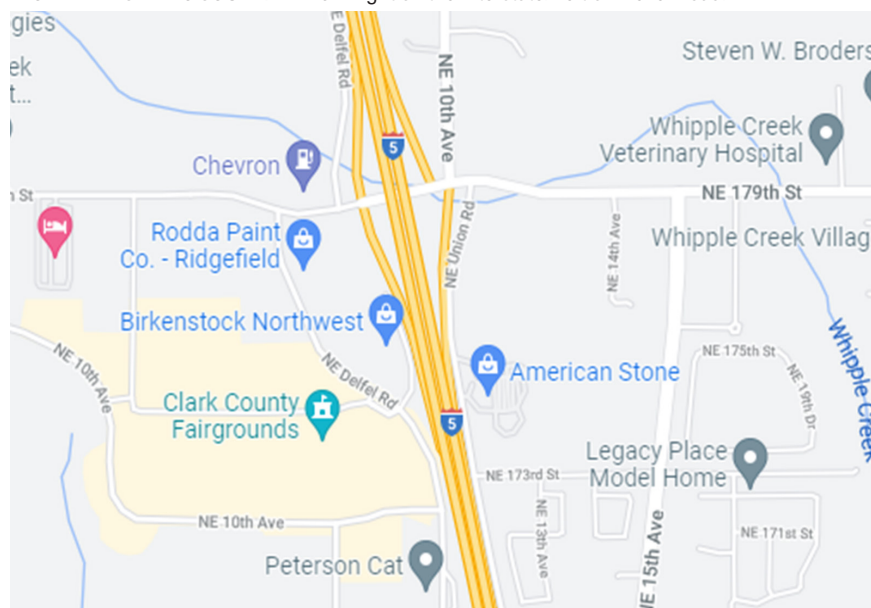
OBEDIENCE OR RALLY: A transfer (i.e., from an obedience
class to an obedience class; or a rally class to a rally class)
may be requested if, according to the owner's records
the handler and dog are eligible provided the club offers
transfers. Transfers from an "A" to "B" class at the same level
are allowed provided the host club allows transfers. The
request for a transfer must be in writing and presented to the
Superintendent or Trial Secretary at least 30 minutes prior to
the start of each trial. Clubs may choose to accept transfers
prior to the day of the trial and this should be clearly stated
in the premium list. Transfers may be approved provided the
class and judge are available, and the class has not reached
its limit. For Bitches in Season, refer to General Rules in
Premium List.

- Dogs must be removed from the show site by 8:00PM, Sunday.
- All adults with children or who have supervision over minors are responsible for these minors while on the grounds.
- Fire lanes and designated areas must be kept clear. No parking in these areas.
- Each exhibitor is responsible for cleaning up after his/her own dog(s).
- THIS IS A SELF-CLEAN SHOW. Pooper-scoopers will be placed around the show grounds for your convenience. If your dog soils in the show ring, the ring steward will hold your dog while you do the clean-up. A pooper-scooper will be placed outside each ring. Responsible dog owners realize cleaning up after their dogs is their responsibility!

The Event Center does not have a campground. We offer designated spots as a convenience to show participants and exhibitors to park RVs. **Electric Power is not guaranteed.** There are no hook-ups and no dumping of grey water or sewage on the grounds.

Following are the guidelines for RV and tent camping on the grounds. Please ensure you are aware of all policies.

- RVs should be pre-registered and paid prior to arrival. Parking hangtags issued by the Event Center with paid dates must be displayed at all times.
- In most instances, multiple outlets are located at each power source. Please bring an extension cord (minimum 50') and a 110-volt adapter.

- Please be mindful of your power consumption, as more than one unit may be sharing a circuit breaker. The use of multiple appliances at one time may result in a loss of power for yourself and up to three other units.
- RVs and motorhomes must have stabilizer pads at least 18" x 18" under each support point. Failure to use stabilizer pads will result in a \$150 fee.
- Only registered RVs may park in designated spaces. Due to limited space, it may be necessary to park support vehicles and/or trailers away from RV spots or in exterior lots.
- FSMG/Clark County Event Center has the authority to designate the location of each RV spot, as well as have vehicles towed, and if necessary, request the removal of disruptive campers, or campers that are not following the guidelines set forth in this document.
- No RVs or camping vehicles may be plugged into outlets inside buildings.
- Do not open gates, remove fencing or cones, and do not access any building other than those rented for the event. You must remain in the area rented by the Show Chair/Organizer and may not enter other areas.
- Do not drive across or park in any grass areas.
- Absolutely no alcohol is permitted outside of RVs/Tents. Any alcohol consumption outside of RVs/Tents may lead to being trespassing from the Fairgrounds.
- Cannabis is not permitted on the grounds at any time.
- No open flame fires are permitted on the grounds. This includes portable propane fire pits. Propane grills are allowed.
- Absolutely no dumping of gray water or sewage on the grounds.
- Courteous respect for other campers is expected. Quiet time is from one hour after the event ends until one hour prior to the event start time the next day.
- If security personnel are onsite, they are present to ensure public safety. As such, they have access to any and all areas of the event.
- Pets may not be tied outside RVs/Tents unattended and must be leashed at all times. If pets disturb other campers, it may become necessary to remove the pet from the Fairgrounds. Owners are responsible for care and clean-up after pets. Dogs are not allowed in restrooms at any time. Fairgrounds Site Management Group and Clark County will not assume any responsibility for pets.
- Fairgrounds Site Management Group and Clark County, its employees, directors, officers and volunteers are held harmless against any lost, stolen or damaged units or items or injury to pets or their owners.
- Should questions arise during the event, please contact the show organizer for assistance.
