DIRECTIONS TO CLINIC: Depart training grounds, turn right onto East Valley Parkway. Go to traffic light at El Norte (previously called Washington) and turn right. Stay on El Norte to Centre City Parkway. Turn left on Centre City and follow down to Citracado Pkwy (1 mile past Major Market shopping Center). Turn left on Citracado.

OBEDIENCE & RALLY TRANSFERS WILL BE ACCEPTED FOR THESE TRIALS ACCORDING TO CH. 1, SEC. 16a, OBEDIENCE REGULATIONS.

Move-ups will be allowed at this trial. Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the Secretary at least 30 minutes prior to the start of each trial.

TRANSFER OF ENTRIES

NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON MONDAY, JUNE 2. AFTER THIS TIME, YOU MUST CONTACT THE TRIAL SECRETARY ON SITE.

A transfer must be made to the Superintendent prior to the judging of the class at the show.

OBEDIENCE OR RALLY: A transfer (i.e., from an obedience class to an obedience class; or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible provided the club offers transfers. Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. The request for a transfer must be in writing and presented to the Superintendent or Trial Secretary at least 30 minutes prior to the start of each trial. Clubs may choose to accept transfers prior to the day of the trial and this should be clearly stated in the premium list. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. For Bitches in Season, refer to General Rules in Premium List.

SPECIAL AWARDS ELIGIBILITY FORM

Most of the awards previously listed can be determined through your entry form. However, there are a few awards from the regular classes that you must indicate eligibility. These are listed below. You may send the form in with your entry form. Forms will also be available the day of the trial at each ring.

- **NOTE:** Not all GPS will guide you correctly to the published show address. If you are having trouble – please enter the intersections of Beven Dr and E Valley Pkwy. We have found that Google Maps is the most accurate.
- **Via I-15 S:** Exit El Norte Parkway; Turn left (East) onto El Norte Parkway continuing to East Valley Parkway; Turn left on East Valley Parkway; Turn left at Beven Drive; parking for the trial will be in open field on your right.
- **Via I-15 N:** Take exit 27 for Via Rancho Pkwy toward Felicita Park/San Diego Wild Animal Park; Turn right on E Via Rancho Pkwy; Turn right onto E Valley Pkwy; Turn left at Beven Drive; parking for the trial will be in open field on your right.
- **Via CA-78 E:** CA-78 to I-15 North, exit El Norte Pkwy; Turn right on El Norte Pkwy continuing to East Valley Pkwy; Turn left on East Valley Pkwy; Turn left at Beven Drive; Parking for the trial will be in open field on your right.
