## EXHIBITORS PLEASE NOTE UPDATED COVID INFORMATION

The state of Wisconsin has lifted requirements for the wearing of masks, masks will not be required unless a judge requests masks be worn when exhibiting in their ring. If a mask is required in a ring it will be posted as such for that ring and masks will be available ringside.

Reserved and open grooming in the buildings Only hand held dryers and cage fans will be allowed to be used. Forced air dryers will be ONLY allowed to be used in outdoor areas.

All rings will still have separate entrance and exits. Please make sure you follow the signs to prevent road blocks. Armbands will be available on the table located at each ring for exhibitors to pick up. No armbands will be handed out by the stewards.

Hand sanitizers will be available at each ring as well.

## ROUTES TO SHOW

THE WAUKESHA COUNTY EXPOSITION CENTER is located a short 20 minutes West of Milwaukee with easy access from I-94 - Exit #294 to the South (Hwy J) to Northview Road, (Hwy FDT). Turn Right on Northview Road to the Expo entrance.

## • NOTE •

In order to comply with the provisions of Wisconsin Statutes [s. 95.21 (2)] and Administrative Codes [s. ATCP 11.52], relating to the Statewide Rabies Control Program, the owner of any dog kept or exhibited in Wisconsin (other than a dog kept for educational or scientific purposes) shall have the dog vaccinated against rabies by a veterinarian at no later than 5 months of age and revaccinated within one year after the initial vaccination. Any person (including out-of-state exhibitors) who imports a dog into Wisconsin (for exhibition or any other purpose) must have a valid interstate health certificate or certificate of veterinary inspection for that dog, regardless of the age of the dog. The certificate must be completed by a veterinarian; accompany the dog when it enters this state; and indicate the current vaccination status of the dog. Vaccinations shall be administered by a veterinarian and comply with age and time standards and label instructions approved by the federal bureau for the type of vaccine used.

## TRANSFER OF ENTRIES

**NOTE: TRANSFER OF ENTRIES AND REQUESTS FOR REFUNDS FOR PUBLISHED JUDGE CHANGES WILL NOT BE ACCEPTED IN THE OFFICE AFTER 12:00 NOON ON TUESDAY, JULY 27. AFTER THIS TIME, YOU MUST CONTACT THE SUPERINTENDENT ON SITE.**

**CONFORMATION:** Dogs may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is presented to the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging at the show.

**JUNIOR SHOWMANSHIP:** Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent prior to the start of the class at the show. Correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer must be made to the Superintendent prior to the judging of the class at the show.

## **EXPO RULES AND RV GUIDELINES**

THESE RULES WILL BE STRICTLY ENFORCED. Anyone who either ignores the directions of the Parks staff at the gate or bypasses them in some manner will be subject to a show committee hearing, per the Waukesha Kennel Club.

- The only vehicles allowed within the show area (within 50' of all rings), are First Aid, Security, Expo Staff, and Waukesha Kennel Club dog show staff. All private golf carts, utility vehicles, and ATV's must be used around the outer perimeter of the event.
- Day RV Parking ONLY in Gate #1. No overnight parking will be allowed. Anyone who chooses not to abide by this rule will be asked to move their RV to the overnight RV parking area through Gate #3 and will be required to pay the appropriate overnight fees. Noncompliance will result in your RV being towed at your expense.
- Entrance to RV Camping is Gate #3. Upon arrival to Gate #3, participants will need to provide a copy of their registration confirmation. Once registration has been verified, a parking pass will be provided to be displayed in the window of the RV. Access to Gate #3 is limited to:
  - o Recreational vehicles with proper parking pass displayed in the window.
  - o Handler/Exhibitor vehicles with proper parking forms displayed in window. One vehicle per site. Any handler/exhibitors without proper parking confirmations must enter through Gate #1 and use the designated "Handler Drop Off area."
  - o Club members and workers with appropriate pass (Friday – Sunday).
- After 9:00PM, RVs are welcome to enter Gate #3 to be staged in Arena West Parking Lot until the next morning. No electrical hookups available. Wednesday arrivals are welcome from Noon – 9:00PM.
- A noise curfew is in effect from 10 p.m. until sunrise. This applies to all types of loud noises, including, but not limited to, music and stereos. Please be considerate of your neighbors so everyone can have a pleasant time.
- Grills are allowed by individual RV sites only, not on the show grounds. Hot coals should not be dumped into Expo trash containers or dumpsters. Absolutely NO campfires of any kind are allowed.
- No tent camping will be allowed.
- All dogs must be kept on a 6 ft. or less leash, unless in designated dog show rings.
- All campers are responsible for cleaning up and properly disposing of all trash, recyclable items and dog droppings. Place items in proper receptacles found throughout the Expo Grounds. Failure to follow this rule may result in additional charges or not being allowed to camp on-site for future shows.
- Cancellations of RV Camping and Handler Parking: A full refund will be given if canceled on or before July 14, 2021. If canceled July 14, 2021 or later, the reservation fee will be forfeited.
