Directions To the Emergency Animal Clinic from the Coliseum: Head North on Parnell Avenue from the Coliseum parking lot. Turn right off of Parnell on to State Road 930 (Coliseum Blvd), go East to State Road 37 (Stellhorn Road), turn left. Go to Maplecrest Road and turn left. The Emergency Animal Clinic is approximately 2 miles, on the East side of Maplecrest Road. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and have appropriate vaccinations.
