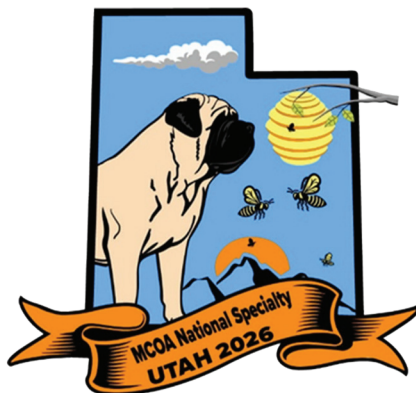

NOTICE TO EXHIBITORS - ALL EVENTS



The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The American Kennel Club will collect the following at every Licensed or Member club event: An AKC Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES - Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE - The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS - By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

SPECIAL RECOGNITION

AWARD OF MERIT (NATIONAL & REGIONAL): Following the Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety and Selects have been awarded; the judge may select Award of Merit Winners from the remaining dogs and bitches in competition. The number of these awards is 10% of the Best of Breed Entry. These Awards of Merit are reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed. The dogs selected for Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, & Select Bitch are not eligible for an Award of Merit.

BEST BRED-BY EXHIBITOR, BEST PUPPY, BEST VETERAN: Eligibility for Best Bred-by Exhibitor, Best Puppy, Best Veteran competitions is predicated upon entry into the following class(es) and all divisions of:

- Best Bred-By Exhibitor – the Bred-by-Exhibitor class including the Bred-by-Exhibitor Puppy and Bred-by-Exhibitor Adult age divisions
- Best Puppy – any class limited to dogs six months and older and under 12 months of age; 6-9 Puppy, 9-12 Puppy, and Bred-by-Exhibitor Puppy
- Best Veteran – any non-regular Veteran Class

For Best Bred-By Exhibitor, the eligibility criteria involving the individual handling the dog applies only to the original class entered and all competition specific to the special attraction (i.e., BBE Groups and BBE BIS). There are no restrictions as to who may handle the dog in any subsequent classes it may become eligible.

NOTE: Best Veteran, Best Puppy or Best Bred By Exhibitor competition will be forgone if the Best of Breed is one of the above.

Note: Chapter 11, Section 8, of the Dog Show Rules provides that castrated males & spayed females may be entered in the Veteran Classes at independent specialty shows only.*

BEST OF BREED (VARIETY) COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Selects, if applicable, will be chosen following Best of Breed.

SELECTED IMMEDIATELY FOLLOWING BEST OF BREED: Select Dog/Bitch, and then Awards of Merit, followed by NOHS Best of Breed, Best Puppy, Best Bred By Exhibitor, and Best Veteran - see page 6.

****Points Available for Reserve****

The Mastiff Club of America, Inc. will award at its National Specialty & the Redwood Empire Mastiff Club, Inc. will award at its Independent Specialty a three point major to Reserve Winners Dog if the Regular Class Dog entry is twice the required number for a five point major in the division where the National Specialty is held. The Mastiff Club of America, Inc. will award at its National Specialty & the Redwood Empire Mastiff Club, Inc. will award at its Independent Specialty a three point major to Reserve Winners Bitch if the Regular Class Bitch entry is twice the required number for a five point major in the division where the National Specialty is held.

IMPORTANT REMINDER: The MCOA Nationals & REMC Independent Specialty are preceded by four all breed shows hosted by Mt. Ogden KC and three concurrent specialties. If mastiff entries at the three concurrent specialties, National and Independent specialties, meet the reserve major criteria above, there is the potential of 14 majors for each sex. NON-REGULAR CLASSES - MULTIPLE DOG ENTRIES - NATIONAL ONLY

NOTE: As the judge's decision in the Stud Dog, Brood Bitch, Brace, and Team Classes is based upon the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes.

STUD DOG CLASS - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if a Champion of Record, for Best of Breed/Variety Competition or may be entered for Stud Dog Class only at the regular entry fee. The Get **MUST** be entered in one of the Regular or Non-Regular Classes. The Stud Dog unit shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with their Get. Get only to be judged on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under AKC Rules Applying to Dog Shows, AKC Policy or Standard for the Breed.

BROOD BITCH CLASS - same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

NOTE: Chapter 11, Section 8, AKC Rules Applying to Dog Shows provides that castrated males may be entered as Stud Dog and spayed females may be entered as Brood Bitch.

BRACE CLASS - Two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs in the Brace must have at least one common owner. Dogs comprising a Brace must be named at the time of entry. If a dog which is to be part of a Brace is **NOT ENTERED** in another class at this show, it must be entered for "BRACE CLASS ONLY". In making entries for "Brace Class Only", full particulars must be given on an Official AKC Entry Form. If the dog is entered in another class, Brace must be marked as an "Additional Class". If more than one Brace is entered by an individual owner, please designate dogs comprising each Brace as "Brace # 1", "Brace # 2", etc.

TEAM CLASS - A Team is defined as four dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in team competition must have at least one common owner. The dogs comprising a Team **MUST** be named at the time of entry. If a dog which is to be part of a Team is not entered in any of the Regular Classes or for "Best of Breed Competition", it must be entered for "Team Only". In making entries for "Team Only" full particulars must be given for each dog on individual regular entry forms. An entry for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as a part of a Team **MUST** be marked accordingly in the space provided for Additional Classes - Team Class. If more than one Team is entered by the same owner, the dogs comprising **EACH** Team must be so designated "Team No. 1", "Team No. 2", etc.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

RESERVE JUNIOR HANDLER: After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

REMC Specialty - Tuesday - National - Thursday

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Entry and Eligibility

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E."
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with Amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and Amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

NO PUPPIES UNDER THE AGE OF SIX (6) MONTHS, EXCEPT THOSE PARTICIPATING IN THE 4-6 MONTH PUPPY COMPETITION, MAY BE ON THE GROUNDS.

FUTURITY/MATURITY STAKE RULES - NATIONAL ONLY

PURPOSE The purpose of the MCOA Futurity and Maturity is to encourage the breeding of the best possible Mastiffs, reward diligent MCOA breeders for their efforts, recognize the owners for selecting the best quality puppies from responsible breeders, and reward the owners and breeders for raising and developing the inherited qualities of the puppy.

In nominating a litter for the Futurity, MCOA members are casting their vote of confidence in their breeding decisions and indicating their commitment to improving the quality of our mastiffs.

In addition, the Maturity Stakes not only provide Futurity-nominated puppies with an additional opportunity to compete but also gives those unable to participate in a futurity the chance to compete during the next National Specialty in the Maturity stakes.

GENERAL

Key steps for this are:

1. Nominate litter: \$25 per litter, split \$15 to Futurity, \$10 to Maturity.
2. Nominate puppies: \$25 per puppy, split \$15 to Futurity, \$10 to Maturity.
3. Enter at upcoming National Specialty based on age of the puppies

Nomination forms may be secured from the MCOA Website.

Mail Forms to Futurity/Maturity Director.

Mail Checks to MCOA Treasurer with "Futurity/Maturity nomination" in memo section or pay via PayPal.

DIVISION OF STAKE MONEY

GENERAL

35% to operating expense fund.

65% to be divided for futurity prize money.

Division of Futurity prize money

10% to Grand Futurity Winner

3% each to Best Futurity Puppy and Best Futurity Junior

2% each to BOS Futurity Puppy and BOS Futurity Junior

The 80% remaining will be split for the classes, pro-rated by the number of dogs entered in each class, with 40% going to first place, 30% to second, 20% to third place, and 10% to fourth place.

Division of Maturity prize money

10% to Grand Maturity Winner

3% each to Best Maturity Junior and Best Maturity Senior

2% each to BOS Maturity Junior and BOS Maturity Senior

The 80% remaining will be split for the classes, pro-rated by the number of dogs entered in each class, with 40% going to first place, 30% to second, 20% to third place, and 10% to fourth place.

Division or Prize money for Futurity and Maturity

40% to Breeder. 60% to Owner.

Prize money is awarded and claimed only at the National Specialty. Unclaimed checks will be deposited in the Maturity fund for the following year.

Futurity/Maturity Approved Motions:

Effective 2007 Futurity the Futurity/Maturity Director is eligible to participate in Futurity/Maturity Competition.

Effective per Motion Oct 2017 There is no longer an award for Best of Opposite Sex to Best in Futurity or to Best in Maturity.

Step 1: NOMINATION OF LITTER

Nomination must be made by be an MCOA member and be the breeder or co-breeder.

Nomination must be made after the breeding, but before puppies are whelped. The postmark on the entry envelope is the official date of nomination.

Nomination fees cannot be transferred from one litter to another nor from one bitch to another. There will be no refunds.

The nomination of a litter makes all puppies in the litter eligible for individual nomination in both Futurity and Maturity.

*Litters nominated in the month of November will have their futurity year determined by the futurity director based on the date of the next national specialty.

Step 2: NOMINATION OF PUPPY

Nomination must be made by the legal owner or co-owner of the puppy as of the date of nomination. Nomination must be made before the puppy reaches four (4) months of age. The postmark on the envelope is the official date of nomination. There will be no refunds.

An entire litter may be individually nominated by the breeder for Futurity and Maturity before puppies are sold by paying fee for each puppy and supplying (for each puppy):

- A. Litter Registration Number
- B. Whelping Date,
- C. Name
- D. Sex

Step 3: ENTER FUTURITY STAKES

Requirements to enter Futurity Judging:

The puppy must be entered in one of the regular classes, either in conformation or obedience at the MCOA National Specialty Show. All entries must be paid in full.

The Futurity entry must include:

- A. Futurity entry must be indicated as an additional class and include the age division (e.g., Futurity 6-9, etc.)
- B. Futurity Classes range in age from six month to the nineteenth month

Class divisions are:

- A. 6 to 9 months, Puppy
- B. 9 to 12 months, Puppy
- C. 12 to 15 months, Junior
- D. 15 to 19 months, Junior

Puppies are eligible only for the first Futurity Stake Show that is held in conjunction with the first MCOA Specialty Show held on or after the date the puppy reaches six (6) months of age.

Individuals **handling** the dogs in Futurity Competition must be:

- A. An Owner or Co-owner or
- B. A Breeder or Co-Breeder or
- C. MCOA Member or Associate MCOA Member in good standing* with MCOA and AKC.
This includes professional handlers.

*In Good Standing - members & associate MCOA members that are not in a suspended status with AKC or MCOA.

Step 4: ENTER MATURITY STAKES

Requirements to enter Maturity Judging:

Maturity entries are eligible to compete only in the first Maturity Stake held following the Futurity stake for which they were nominated.

While the nomination must have been made for Futurity, entry or participation in the Futurity Stakes is not required for Maturity judging. Thus, if a puppy is not able to attend their futurity year, they may still enter in maturity the following year.

The dog entering a Maturity class must be entered in one of the regular classes, either in conformation or obedience at the MCOA National Specialty Show. All entries must be paid in full.

The Maturity entry must include:

- A. Maturity entry must be indicated as an additional class and include the age division.
(e.g., Maturity under 24 Months or Maturity over 24 Months)
- B. Maturity Class divisions are:
 - 1. Junior- Under 24 months
 - 2. Senior-Over 24 months

Individuals **handling** the dogs in Maturity Competition must be:

- A. An Owner or Co-owner or
- B. A Breeder or Co-Breeder or
- C. MCOA Member or Associate MCOA Member in good standing* with MCOA and AKC.
This includes professional handlers. .

*In Good Standing - members & associate MCOA members that are not in a suspended status with AKC or MCOA.

SEQUENCE OF JUDGING - Futurity

Step 1: Judging sequence will be all dog classes (6-9 month through 15-18month) followed by all the bitch classes.

Step 2:

- a. The judge will have the first-place winners of the 6-9 and 9-12 dog and bitch classes return to the ring to select a Best Futurity Puppy and a Best of Opposite Sex Futurity Puppy.
- b. This sequence will be repeated for the first-place winners of the 12-15 and 15-19 dog and bitch classes and the judge will select a Best Junior and Best of Opposite Junior winner.

Step 3: The Best Puppy and Best Junior Puppy compete for Grand Futurity Winner.

SEQUENCE OF JUDGING - Maturity

Step 1: Judging sequence will be all dog classes (Junior- under 24 months and Senior-Over 24 months) followed by all the bitch classes.

Step 2:

- a. The judge will have the first-place winners of the Junior- under 24 months dog and bitch class return to the ring for the judge to select Best Maturity Junior, followed by Best of Opposite Sex Maturity Junior.
- b. This sequence will be repeated for the first-place winners of the Senior-Over 24 months dog and bitch class and the judge will select a Best Maturity Senior, followed by Best of Opposite Sex Maturity Senior.

Step 3: Best Maturity Junior and Best Maturity Senior will compete for Grand Maturity Winner.

Dogs entered in the MCOA Tournament of Champions must be owned or co-owned by MCOA members/ associate members in good standing only.

**In Good Standing - members and associate members that are not in a suspended status with AKC or MCOA*

The tournament is open to AKC and/or CKC (Canadian Kennel Club.) Champions of Record only by the closing date for entries. Dogs entered in this competition must be eligible to compete in AKC Dog Shows. There shall be no neutered dogs or spayed bitches allowed to compete in this competition. Judging shall be based on overall soundness, quality of movement and type as defined in the breed standard. Ideally judges chosen for Tournament shall be a breeder, a professional handler and an AKC or Provisional judge. In the event of a last-minute judge change, entrants that may have a potential conflict of interest may request a refund of the entry fee. The judge also has the right to refuse to examine a dog if they feel there is a conflict of interest.

The Tournament of Champions is a non-regular AKC competition and therefore has some leeway in judging order. Dog/bitch may be moved if there is a handling conflict in the trio to which they are assigned. Contact the Tournament Team, or Chief Ring Steward to have your conflict resolved and the dog/bitch moved to a different trio.

1. The total Tournament entry will **NOT** be brought into the ring together to be checked in.
2. All mastiffs will now be judged in numerical order as per the catalog.
3. The first set of three will enter the ring, one at a time and make an entire circle around the ring and stop at station 1, 2 and 3 after the first time around the ring.
4. The judges will be at three set stations in the ring for the hands-on examination. The mastiffs will move counterclockwise until all three judges have examined all three dogs. Each round of judging should be limited to three minutes a dog in total. Dogs will not be moved individually by a judge during hands on examination.
5. Judges complete the score sheet after each individual exam. The Score sheet will be handed over to the Tournament chairperson or designee.
6. When each dog in the trio has been examined by each judge, the dogs will be moved individually on a diagonal down and back. Finally, as a group they will be moved once around the ring and then exit.
7. Final scoring of the group is completed, judges will review the score sheet to be sure all areas are scored and hand them in.
8. Once scoring is completed the dogs are excused and need not remain for any additional judging.
9. The second group of three mastiffs enters the ring. This continues until all mastiffs have been examined.
10. The score sheets will be tallied.
11. The top ten qualifying mastiff scores will be announced the next day after the scores are double checked. The top ten mastiffs will be presented at an evening event as a highlight presentation with no further judging planned.
12. Tournament Winners will be announced at the awards banquet and the score sheets will be mailed after the national specialty.

The MCOA Breeders' Cup Competition is open to MCOA members only. The Breeder's Cup will be held before the actual judging of the Specialty classes. In this competition each entry consists of a trio of dogs bred by the same breeder or co-breeder. Each trio is to be judged by a three-judge panel of experts on the breed using a point system based on the Mastiff Standard.

RESULTS WILL BE KEPT CONFIDENTIAL UNTIL THE AWARDS BANQUET.

Purpose: In the Breeder's Cup Competition, the breeder or co-breeder is making a statement about his/her breeding program based on a group of three dogs.

- How consistent is the trio in the areas of overall impression, head, structure, movement, presence, and consistency in breed type?
- How closely does the trio adhere to the Mastiff Standard?

Entry in the MCOA Breeder's Cup Competition is open to MCOA members and Associate members in good standing only. *

**In Good Standing - members and associate members that are not in a suspended status with AKC or MCOA.*

Breeder's Cup is a non-regular class per AKC and therefore the following may apply: A breeder/co-breeder may change a dog/bitch in the trio if there is a conflict with one of the dogs entered prior to judging, provided the animal replaced is bred by the same breeder/co-breeder.

Notify Breeder's Cup Coordinator or Chief Ring Steward if there is a handling conflict and the trio needs to be moved at least 2 hours ahead of the scheduled judging time so the trios can be adjusted. Notify Breeder's Cup Coordinator or Chief Ring Steward if the Trio is absent.

BREEDER'S CUP PROCEDURE

1. The total Breeder's Cup entry will not be brought into the ring together.
2. In numerical order, the first trio of mastiffs will enter the ring.
3. Each judge will take a mastiff in trio for the hands-on exam.
4. The scoring is based on the presentation of the trio as a whole.
5. The judges will work through the trio until each judge has completed the hands-on examination of each dog.
6. The trio will move center to of the ring in a line and stack fronts first, then rears.
7. Then they will be individually gaited down and back and restacked. Once all three have gaited, the trio will move once around the ring and out. Judges will complete the scoring and hand in the score sheet.
8. Once the trio has been judged they are excused and do not need to return to the ring.
9. Judging will continue in this manner until all groups are judged.
10. Score sheets are then turned over to the designated Statistician for final tabulation.
11. The top five winners will be announced at Awards Banquet.
12. Copies of the individual results for all entrants will be mailed after the national specialty so all winners receive their sheets.

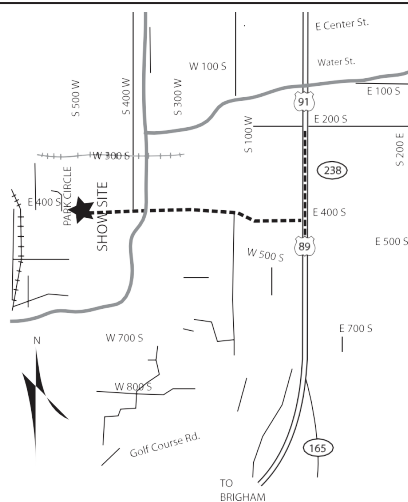
