NOTICE TO EXHIBITORS – ALL EVENTS

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The

American Kennel Club will collect the following at every Licensed or Member club event: An AKC Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

Selected immediately following Best of Breed: Select Dog/Bitch, Awards of Merit, Best from the Regular Puppy Classes, Best from the Bred By Exhibitor Classes & Best Veteran.

SPECIAL RECOGNITION

AWARDS OF MERIT: The Portland Miniature Schnauzer Club will offer Awards of Merit (AOM) providing there are seven or more champions entered. For 12 or more champions entered, an additional award for each four champions will be offered according to the quantities listed below.

7-11 = one AOM, 12-15 = two AOM, 16-19 = three AOM

BEST BRED BY EXHIBITOR: Following Best of Breed, the winners of the Bred By Exhibitor Puppy Dogs/Bitches classes & Bred By Exhibitor Adult Dogs/Bitches classes (only) will compete for Best Bred By Exhibitor. If Best of Winners is from one of the Bred By Exhibitor classes, then Best of Winners is automatically Best Bred By Exhibitor.

BEST PUPPY: The winners of the regular Puppy classes, Puppy Dogs/Bitches (6-9 Mo., 9-12 Mo., and Bred By Exhibitor Puppy Dogs/Bitches classes) compete for Best Puppy. If the winner of any of the mentioned classes was awarded Best of Winners, then the award is automatic

BEST VETERAN: Following Best of Breed, the winners of the veteran classes (only) will compete for Best Veteran. If Best of Breed is from one of the Veteran classes, then Best of Breed is automatically Best Veteran.

PUPPY/JUNIOR SWEEPSTAKES & VETERAN SWEEPSTAKES

PUPPY/JUNIOR SWEEPSTAKES

Puppy/Junior Sweepstakes will be judged prior to the Regular Classes and is open to all Miniature Schnauzers who on the day of the show, will be 6 months of age and under 18 months of age. Classes will be divided by age and sex. All entries in the sweepstakes MUST also be entered in a Regular Class or for Best of Breed at this show. Entries shall be made at the same time and on the same entry forms as for the Regular Classes. Indicate "Puppy/Junior Sweepstakes" and the age division in the space provided for "Additional Classes." Each dog entered must be handled by the owner, by a member of the owner's immediate family, or by an amateur handler with exception that professional handlers may handle only dogs that they own/co-own or are the breeder/co-breeder of record and handle without recompense. All prize money is the property of the owner.

VETERAN SWEEPSTAKES

Veteran Sweepstakes will be judged prior to the Regular Classes and is open to all Miniature Schnauzers who on the day of the show, will be 6 years of age or older. Classes will be divided by age and sex. Champions of Record are eligible for the Veteran Sweepstakes. Each dog or bitch NEED NOT be entered in a Regular Class at the show. Entries shall be made on a regular entry form. Indicate "Veteran Sweepstakes" and the age division in the space provided for "Additional Classes." Dogs and bitches which have been altered (castrated or spayed) may be entered. Entries in the Veteran Sweepstakes may be shown by anyone in good standing with the American Kennel Club.

DIRECTIONS TO KITSAP COUNTY FAIRGROUNDS

FROM TACOMA NARROWS BRIDGE - Take Highway 16 north to Bremerton. At Bremerton take Highway 3 north to Silverdale, exit at Newberry Hill Rd, turn right. Follow Newberry Hill (becomes Silverdale Way) to Bucklin Hill, turn right. Go to Nelson Rd, turn right. At Fairgrounds Rd. turn right, follow to show site.

FROM BREMERTON FERRY - Depart ferry onto Washington (becomes 11th), turn right on to Warren Ave, which becomes Wheaton Way. Stay on Wheaton Way thru East Bremerton to Fairgrounds Rd, turn left. Follow to fairgrounds & show site.

FROM BAINBRIDGE FERRY - Depart ferry through town, follow about 10 miles through Poulsbo to Highway 3. Follow signs south to Silverdale/Bremerton. At Silverdale, follow signs to East Bremerton via Waaga Way. Exit at Central Valley Rd. Follow to Fairgrounds Road, turn right. Follow to fairgrounds & show site.

FROM KINGSTON FERRY - Depart ferry south out of Kingston, follow Bond Rd to Highway 305 at Poulsbo. Turn right, follow signs south to Silverdale/Bremerton. At Silverdale, follow signs to East Bremerton via Waaga Way. Exit at Central Valley Rd. Follow to Fairgrounds Rd, turn right. Follow to fairgrounds & show site.
