The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

The American Kennel Club will collect the following at every Licensed or Member club event:

- First entry of a dog in Conformation or Obedience, a \$3.00 Event Service Fee and \$.50 Recording Fee, plus a \$3.50
   Service Fee for each additional entry of the same dog.
- First entry and each additional entry of a dog in Agility or Rally, a \$3.50 Service Fee.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the
  amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a
  money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may

The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.
   There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made.

- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.

#### JUNIOR SHOWMANSHIP COMPETITION

**NOVICE CLASS:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class.

DFSW will provide extra fancy vanity ribbons for use in photographs only.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

#### 4-6 BEGINNER PUPPY - SATURDAY

The Four-to-Six Month Puppy competition shall be for Dachshunds (Each Variety) that are four months of age and over but under six months on the day of the event.

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for an entry as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E."
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

CLASSIFICATION - CLASSES COMBINED: Puppy, 4 & Under 6 months · Exhibition Only
ENTRIES WILL BE TAKEN THROUGH OUR SUPERINTENDENT

NO PUPPIES UNDER THE AGE OF SIX (6) MONTHS, EXCEPT THOSE PARTICIPATING IN THE 4-6 MONTH PUPPY COMPETITION, MAY BE ON THE GROUNDS.

#### SPECIAL RECOGNITION

**AWARDS OF MERIT:** At the discretion of the judge, Awards of Merit may be given to up to 10% of all dogs eligible for Best of Variety with a minimum of one award. Best of Variety, Best of Opposite Sex to Best of Variety, Select Dog/Bitch, and Best of Winners are not eligible to receive an Award of Merit because it is assumed the judge finds them worthy of merit by the virtue of their win.

**BEST BRED-BY EXHIBITOR ADULT** Eligibility for Best Bred-by Exhibitor Adult competitions is predicated upon entry into the Bred-by-Exhibitor Adult classes of each Variety

Following Best of Breed the winners of all three varieties Bred by Exhibitor Adult Dog & Bitch classes will compete for Best Bred-By Exhibitor Adult of Breed.

For Best Bred-By Exhibitor Adult, the eligibility criteria involving the individual handling the dog applies only to the original class entered and all competition specific to the special attraction. There are no restrictions as to who may handle the dog in any subsequent classes it may become eligible.

NOTE: Best Bred-By Exhibitor Adult of Breed is forgone of if Best of Breed was from the Bred by Exhibitor Adult class.



# AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the
  judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit
  of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- · Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
