EXHIBITORS PLEASE NOTE

Exhibitors should follow their Veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

No dogs that are disqualified for aggression will be allowed to enter these Shows, nor be allowed to be on the grounds. In addition, no aggression reinstatement procedures will be performed at these Shows.

"Dogs found in an unsafe environment, distress or harm's way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm's way is considered mistreatment."

BEST OF BREED COMPETITION

SELECT DOG SELECT BITCH

The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed competition. This will be followed by NOHS Best of Breed.

BEST IN PUPPY CLASSES: the first place winner of each of the four puppy classes will compete for Best Puppy.

BEST IN BRED BY EXHIBITOR CLASSES: the first place winner of each of the Bred by Exhibitor classes will compete for Best Bred by Exhibitor.

BEST IN VETERAN CLASSES: the first place winner of each of the Veteran classes will compete for Best Veteran.

Non-Regular Classes Involving Multiple Dog Entries

NOTE: As the judges' decision in the Stud Dog & Brood Bitch Class is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class. Chapter 11, Section 8 of the Dog Show Rules provides that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Stud Dog Class – For Stud Dogs and two (2) of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. Owner of Stud Dog need not necessarily be owner of get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered individually in one of the Regular Classes, or Best of Breed Competition.

Brood Bitch Class – Same as Stud Dog, except substitute "Brood Bitch" for "Stud Dog" and "Produce" for "get".

NOVICE CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

Sweepstakes is open to all Doberman Pinschers that, on the day of the show, will be at least 6 months of age & under 18 months of age. Dogs shown in Sweepstakes must also be entered in one of the regular classes at the regular entry fee and on the regular entry form. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class." Dogs entered in Sweepstakes can be shown by anyone: owner, amateur or professional handler. Dogs that have attained their championship are NOT eligible to be shown in the Sweepstakes.

The following classes will be provided for both dogs and bitches.

Puppy, 6 Mos & Under 9 Mos • Puppy, 9 Mos & Under 12 Mos

Junior, 12 Mos & Under 15 Mos • Junior, 15 Mos & Under 18 Mos

DIVISION OF ENTRY MONEY AS PRIZES

35% of total entry fees will be retained by the Club for expenses. The remaining 65% will be divided as follows: One-half of each net division stake shall be divided one-quarter to the dogs and one-quarter to the bitches as follows:

1st Place - 40%; 2nd Place - 30%; 3rd Place - 20%; 4th - Place - 10%.
