NOTICE TO EXHIBITORS



The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

The American Kennel Club will collect the following at every Licensed or Member club event:

- First entry of a dog in Conformation or Obedience, a \$3.00 Event Service Fee and \$.50 Recording Fee, plus a \$3.50 Service Fee for each additional entry of the same dog.
- First entry and each additional entry of a dog in Agility or Rally, a \$3.50 Service Fee.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Clubs is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

Winners, if otherwise undefeated, are eligible for Best of Breed competition.

Veteran & Field Dogs/Bitches: Per AKC Rules Applying to Dog Shows, effective June 28, 2023, neutered dogs and spayed bitches are allowed to compete in Veterans and all other single entry non-regular classes only at independent specialties which do not offer any competitive classes beyond Best of Breed."

BEST OF BREED (VARIETY) COMPETITION

SELECT DOG SELECT BITCH

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed competition. This will be followed by NOHS Best of Breed, Awards of Merit, Best Bred-By-Exhibitor, and Best Puppy (see below.)

AWARDS OF MERIT & SPECIAL RECOGNITION - ALL EVENTS

AWARDS OF MERIT: After Best of Breed, Best of Winners and Best of Opposite Sex to Best of Breed and Select Dog and Bitch are judged, the remaining dogs in the ring will stay (including Best of Opposite Sex, Winners Dog and Winners Bitch) for the judge to give Award of Merit Rosettes to up to 10% of the dogs entered in Best of Breed.

BEST BRED-BY-EXHIBITOR & BEST PUPPY: Eligibility for Best Bred-by-Exhibitor or Best Puppy is predicated upon entry into the following class(es) and all divisions of:

- Best Bred-By-Exhibitor - Bred-By-Exhibitor class including the Bred-By-Exhibitor Puppy or Bred-By-Exhibitor Adult age divisions
- Best Puppy - any class limited to dogs six months and older and under 12 months of age; 6-9 Puppy, 9-12 Puppy, and Bred-By-Exhibitor Puppy

For Best Bred-By-Exhibitor, the eligibility criteria involving the individual handling the dog applies only to the original class entered and all competition specific to the special attraction. There are no restrictions as to who may handle the dog in any subsequent classes for which it may become eligible.

NOTE: Best Puppy or Best Bred-By-Exhibitor competition will be forgone if the Best of Breed is one of the above.

CONFORMATION CLASSIFICATION - NATIONAL SPECIALTY ONLY

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

STUD DOG CLASS - For Stud Dogs and their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of the Stud Dog need not necessarily be owner of the Get. Get only to be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under Dog Show Rules, AKC policy, or the standard of the breed. Get must be entered in a Regular Class, Best of Breed Competition or some other Non-Regular Class.

BROOD BITCH CLASS - Same as Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get. As the judge's decision in the Stud Dog and Brood Bitch Classes is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won this class.

NOTE FOR BOTH: The Get/Produce MUST be entered and shown individually in another class.

BRACE CLASS: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

AKC SANCTIONED 4-6 MONTHS PUPPY - THURSDAY & SUNDAY

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E."
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

SWEEPSTAKES & VETERAN SWEEPSTAKES - ALL EVENTS

SWEEPSTAKES

Sweepstakes is open to German Wirehaired Pointers that are 6 months and under 18 months of age on the day of the show. Dogs shown in Sweepstakes must be entered in one of the regular classes. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class." Anyone in good standing with the AKC may handle an entry.

SWEEPSTAKES CLASSES

Classes will be divided by sex.

6 - 9 months • 9 - 12 months • 12 - 15 months • 15 - 18 months

VETERAN SWEEPSTAKES

Sweepstakes is open to German Wirehaired Pointers that are over 7 years of age on the day of the show. Dogs shown in Sweepstakes must be entered in one of the regular classes. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class." Anyone in good standing with the AKC may handle an entry. Altered Dogs/Bitches may be shown.

VETERAN SWEEPSTAKES CLASSES

Classes will be divided by sex.

FUTURITY

All dogs entered in the Futurity must be owned & co-owned by a member of the German Wirehaired Pointer Club of America. All dogs must be entered in a regular class at the GWPCA National Specialty show.

FUTURITY CLASSES

Classes will be divided by sex.

Junior Class - Whelped on or after December 1, 2024 through March 31, 2025

Intermediate Class - Whelped on or after August 1, 2024 through November 30, 2024

Senior Class - Whelped on or after April 1, 2024 through July 31, 2024

DIVISION OF FUTURITY PRIZE MONEY

Actual expenses will be deducted from the Futurity money. The remainder will be divided as follows:

Best in Futurity - 12.5% Best of Opposite Sex - 12.5%

JUNIOR SHOWMANSHIP COMPETITION - FRIDAY, SATURDAY & SUNDAY

NOVICE CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

PEE WEE SPECIAL ATTRACTION - FRIDAY & SUNDAY

Entries will be taken the morning of the show at the Club table.

The Pee Wee Special Attraction is a pre-Junior Showmanship class.

Safety is a primary concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- The dogs must be German Wirehaired Pointers.
- Bitches in season will not be allowed to participate.
- All dogs entered must have the proper lead & collar.
- Judging will be held during a break - See Judging Schedule.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- Each parent/guardian must sign a waivers/entry blanks - available at the club table.

Because safety of both the dogs and Juniors is a primary concern an additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

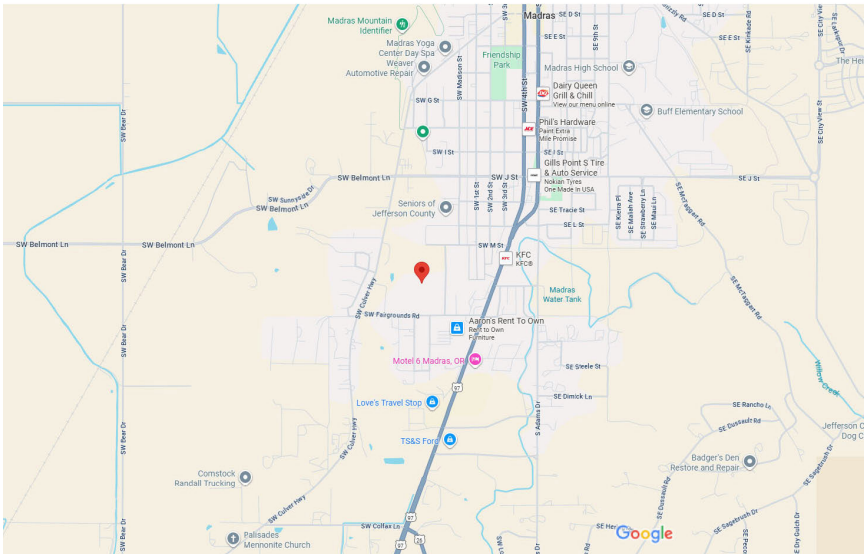

All-Star Invitational Entry Qualifications:

The All-Star Invitational is open to any dog which has earned the following titles:

- Champion/Field Champion (DC)
- Champion/Amateur Field Champion
- Champion/Master Hunter
- Champion/NAVHDA Utility Prize (***all dogs with a passing score in a NAVHDA Utility Test are invited to compete***)

Per existing scoring, any dog entered in the competition which has earned the superlative of: GWPCA National Field Champion, GWPCA National Amateur Field Champion, NAVHDA Versatile Champion or Best in National Specialty Show will be awarded 10 bonus points to their final judged score.

A panel of three judges will be selected by and known only to the Judges Liaison for the All-Star Invitational. The Judges Liaison of the Invitational will not enter, handle, breed or own a dog in competition in the event. The Judges Liaison will be designated every year. The 2025 Judges Liaison is Laura Reeves.

Selected judges will evaluate the dogs on the following existing scoring system:

1. Overall Impression (type, balance, outline, size, substance, condition, temperament) -25 points
2. Structure (head, neck topline, tail set, forequarters, hindquarters)-25 points
3. Coat (texture, density, condition, functionality)-25 points
4. Movement (coming at you, going away, side gait, stability of topline)-25 points

Award(s):

Every dog entered will receive a rosette printed with its name.

The winner of the All-Star Invitational Judging will receive a rosette and trophy and have their name engraved on the perpetual Stephanie Strassman Traveling Trophy.

The winner of the People's Choice Award will receive a rosette.

Changes to this selection process are as follows. People's Choice Award Ballots will be available at the door. Each person may purchase ONE ballot. Cost is \$10/ballot. 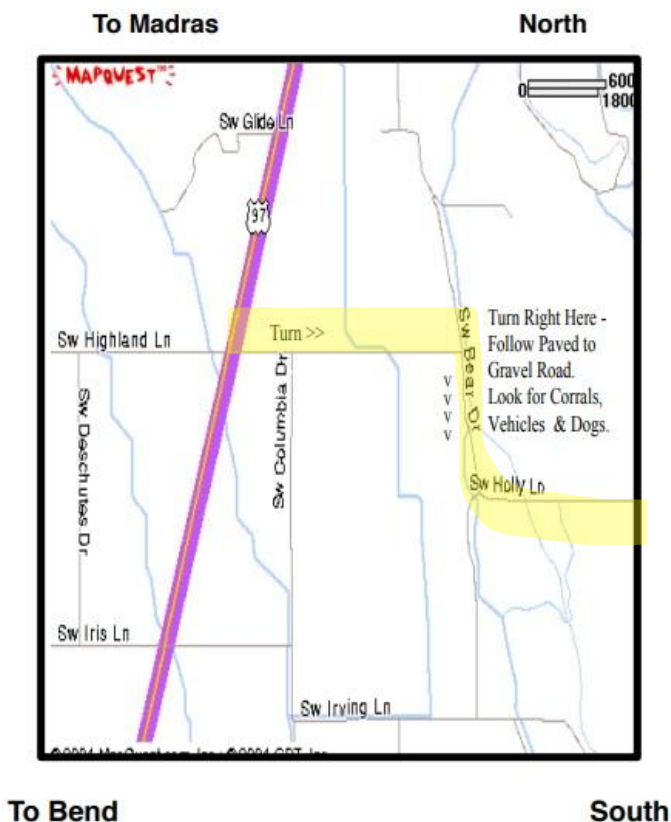
