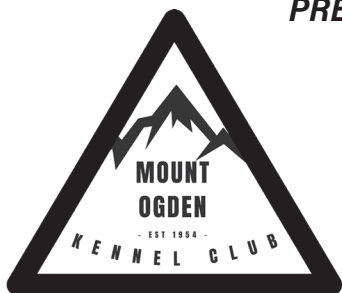

NOTICE TO EXHIBITORS – ALL EVENTS



The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The

American Kennel Club will collect the following at every Licensed or Member club event: An AKC Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.**
- **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.** BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- **REFUNDS** for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent **AFTER THE SHOW.** An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- **FAX ENTRIES** – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for **DUPLICATE ENTRIES** or **OVERPAYMENTS**. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show **NO REFUND** will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- **LOSS OR DAMAGE** – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- **PUBLICATION RIGHTS** – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Selects, if applicable, will be chosen following Best of Breed.

ATTENTION EXHIBITORS

Please clean up after your dogs on the show grounds and at your motel site. We want to retain these facilities for future events.

Remember, all complaints regarding conduct prejudicial to the sport will be dealt with in accordance with AKC rules, by the Show Committee. This includes dogs relieving themselves on the shrubbery outside the show buildings.

SMOKING will not be permitted inside show buildings - state law, or around show rings. This will be enforced.

The Show Site & RV parking will be available to exhibitors after 2:00PM Tuesday. On Wednesday, parking will be available after 10:00AM. Dogs must be removed from the show site 1 1/2 hours after BIS on Sunday.

May stay overnight Sunday night with approval from the Grounds Chairman.

Due to specialties on Wednesday, if you have reserved parking close to the rings we are unable to park you until the specialties are over

1. Damages caused by vehicles will be the responsibility of those persons bringing vehicles on to the show site.
2. Please be sure that all dogs have current DHL, RABIES & PARVO VACCINATIONS!
3. EXHIBITORS & AGENTS must be governed by any rules & regulations of the Cache County Fairgrounds and/or local restrictions.
4. EXHIBITORS & AGENTS will be held responsible for damages and for keeping the premises clean around their crates and set-ups & grooming spaces.
5. EXHIBITORS & AGENTS must keep dogs under control and restrained at all times.
6. EXHIBITORS & AGENTS are advised to bring adequate shade for the comfort of their dogs and themselves.
7. NO CRATES within 25 feet of the show rings (outdoors) except during breed judging & must be removed immediately following that breed. No set-ups between RV/Parking & rings & concessions & rings. Day parking exhibitors' ex-pens will be allowed in designated area only. Ex-pens for overnight parking will be in parking only. NO GROOMING ALLOWED IN BUILDING OR SHOWER FACILITY.
8. RESTROOMS will be available for the convenience of exhibitors/spectators. Any exhibitor found bathing or grooming a dog in the public restrooms WILL NOT BE ALLOWED TO EXHIBIT AND WILL BE SUBJECT TO ACTION BY THE EVENT COMMITTEE.
9. Shower facilities available for paid reserved overnight parking exhibitors only. NO DOGS ALLOWED IN SHOWER BUILDING.
10. NO OVERNIGHT PARKING allowed except in reserved parking areas (see Parking information on page 16).
11. Mount Ogden Kennel Club, Inc. and Cache County Fairgrounds assume NO LIABILITY for loss or damage to equipment, property and/or exhibitors and agents.
12. No roller blades or skateboards allowed on show grounds.
13. Bring mats or other appropriate ground cover for grooming building.
14. Utah State Law prohibits smoking in public areas. **"NO SMOKING"**
15. **Speed limit of 5mph for the safety of exhibitors and public.**

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

RESERVE JUNIOR HANDLER: After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

JUNIOR "BEST OF THE BEST"

Junior Handling Competition "The Best of the Best"

This is restricted to the winners of all specialties and MOKC Junior Handling competition from May 13, 2026 thru May 17, 2026. This competition will be held on Sunday at lunchtime. The winner will be awarded a \$500 scholarship offered by Mount Ogden Kennel Club, to be used at the school of their choice when they enter either a college, trade school, or specialty school. If the junior does not use this scholarship within 5 years of graduation from high school or equivalent education, then the money reverts back to the account of Mount Ogden Kennel Club.

AKC SANCTIONED 4-6 MONTHS PUPPY - ALL 4 DAYS

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Entry and Eligibility

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E."
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

The Club may limit the Beginner Puppy judge to 20.

If this occurs, an additional judge will be named on the Judging Program

NO PUPPIES UNDER THE AGE OF SIX (6) MONTHS, EXCEPT THOSE PARTICIPATING IN THE 4-6 MONTH PUPPY COMPETITION, MAY BE ON THE GROUNDS.

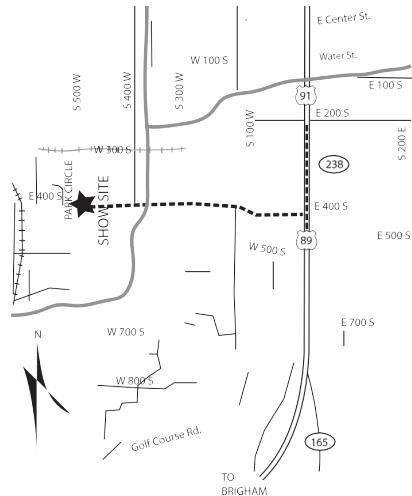

JUNIOR SHOWMANSHIP COMPETITION - NON-SPORTING BREEDS ONLY

NOVICE CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler returns to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Jr. Showmanship Only fee applies.

USE OF RAMPS - NON-SPORTING BREEDS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition: Finnish Spitz.

The following breeds must be judged on a ramp through all levels of conformation competition: Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (06/2025)

AKC SANCTIONED 4-6 MONTHS PUPPY

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for Non-Sporting breeds and varieties as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows.

Entry and Eligibility

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E."
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

NO PUPPIES UNDER THE AGE OF SIX (6) MONTHS, EXCEPT THOSE PARTICIPATING IN THE 4-6 MONTH PUPPY COMPETITION, MAY BE ON THE GROUNDS.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler returns to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show.
