## ***NOTICE TO EXHIBITORS - ALL EVENTS***

**The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The American Kennel Club will collect the following at every Licensed or Member club event: An AKC**

Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES - Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE - The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS - By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed.

**Non-Regular Classes (involving multiple dog entries)**

*Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.*

**BRACE CLASS:** Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

# AKC® Code of Sportsmanship and Civility

**Preface:** The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.

- The Show Site will be available to exhibitors at 1:00PM Thursday. Grounds closed to entry until that time. Dogs must be removed from the show site immediately following Best in Show judging on Sunday.
- The club reserves the right to substitute one trophy for another of equal or greater value. All trophies not claimed the day of the show become the property of the show-giving club.
- Unentered dogs will not be allowed in the arena, grooming or vendor areas at these shows.
- All dogs must be kept on leash when not crated or in exercise pens.
- No exercise pens allowed in the arena or directly adjacent to pedestrian pathways.
- SHOW COMMITTEE WILL BE CALLED FOR ANYONE LEAVING DOG EXCREMENT ON SHOW GROUNDS OR MOTEL PROPERTY.
- Any and all damages caused by the exhibitor will be the sole responsibility of the exhibitor.
- Parents will be responsible for the actions of their children and their conduct both in and outside the Exhibition Center.
- NO DOGS OR CRATES ALLOWED IN RESTROOMS OR BLEACHER AREAS.
- No baby strollers will be allowed in the exhibition area.
- Arena seating available except where posted otherwise.
- Firearms or illegal drugs will not be allowed on the show grounds.
- All cell phones, pagers and other electronics must be turned off while at ringside or in the ring.
- Selling dogs will not be permitted on the show grounds.
- Refreshments: Food & beverages will be available on the show grounds.
- Please use trash containers for disposal. Help us preserve this beautiful show site.
- Show Chairman & Event Coordinator have authority to change rules for the safety and comfort of dogs and exhibitors.
- We expect all exhibitors to display good sportsmanship and act like Ladies/Gentlemen. The Show Committee, in accordance with AKC Rules & Regulations, will deal with violators.
