## **NOTICE TO EXHIBITORS – ALL EVENTS**

**The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.**

The American Kennel Club will collect: a \$3.00 Event Service Fee and \$.50 Recording Fee where applicable for the first entry of a dog, plus a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. Baray Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Clubs is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

### **Non-Regular Classes (Involving Multiple Dog Entries) - Each Variety**

*NOTE: As the judge's decisions in the Non-Regular Classes (Involving Multiple Dog Entries) are based on the merits of more than one dog/bitch, not one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won the class.*

**STUD DOG/ BROOD BITCH CLASS:** For Stud Dogs/Brood Bitches and two of their Get/Produce. The Stud Dog/Brood Bitch must be shown in the ring with the Get/Produce. The class will be judged on the merits of the Get/Produce.

**BRACE CLASS:** A brace is defined as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace must have at least one common owner

*Stud Dog, Brood Bitch & Brace Classes are to be followed by Best Stud Dog, Best Brood Bitch and Best Brace Class competition after Best of Breed has been judged.*

**PARADE OF TITLE HOLDERS:** For dogs that are American Champions, Field Trial Champions, AKC Obedience Title Holders and dogs that have earned a Working Dog Title from the AKC. Parade MUST be indicted on the entry form. All entrants receive a rosette with the dog's name imprinted.

## **SPECIAL RECOGNITION**

**BEST BRED BY EXHIBITOR:** Following Best of Variety the winners of the Bred By Exhibitor Dogs/Bitches classes (only) will compete for Best Bred By Exhibitor of Variety. If Best of Winners is from one of the Bred By Exhibitor classes, then Best of Winners is automatically Best Bred By Exhibitor of Variety. Following Best of Breed the winners of the Best Bred By Exhibitor of Variety will compete for Best Bred By Exhibitor.

**BEST VETERAN:** Following Best of Variety the winners of the Veteran Dogs/Bitches classes (only) will compete for Best Veteran of Variety. Following Best of Breed, the winners of the Best Veteran of Variety will compete for Best Veteran of Breed. If Best of Breed was from a veteran classes, then Best Veteran is automatic.

**OBEDIENCE CLASSIFICATION**

Obedience Class limits: 8 Hours

Regular Classes - Novice Class A & B • Open Class A & B • Utility Class A & B • UDX  
Optional Titrting Classes – Beginner Novice A & B • Graduate Novice • Graduate Open

For class descriptions, refer to AKC Obedience Regulations.

When entries are limited in the regular Open B and/or Utility B classes, a club must designate a regular UDX class in the premium list. Dogs entered in this UDX class would be entered in both Open B and Utility B, and the combined entry fee for these two classes must be paid. Once the limit has been reached in either the regular Open B or the Utility B class, the regular UDX class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety.

**RALLY CLASSIFICATION**

Rally Ring 40’ x 60’ - Rally Trial limited to 70

Regular Classes - Novice Class A & B • Intermediate • Advanced Class A & B  
Excellent Class A & B • Master • RAE • RACH • Choice

For class descriptions, refer to AKC Rally Regulations.

When entries are limited, a club must designate an RAE and a Rally Champion (RACH) class in the premium list. Dogs entered in the RAE class would be entered in both Advanced B and Excellent B, and the combined entry fee for these two classes must be paid. If due to entry limits an exhibitor cannot be entered in both the Advanced B and Excellent B classes the RAE class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety. Dogs entered in the RACH class would be entered in Advanced B, Excellent B and the Master class. The combined entry fee for these three classes must be paid. If due to entry limits an exhibitor cannot be entered in the Advanced B, Excellent B and Master classes the RACH class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety.

Jump height for applicable Obedience & Rally classes MUST be indicated on entry form.

Jump heights in all applicable Obedience classes will begin with 4” and run in ascending order.

Transfers will be allowed per AKC rules. “Dog” means either sex.

**ROUTES TO THE SHOW**

**FROM TACOMA NARROWS BRIDGE** - Take Highway 16 north to Bremerton. At Bremerton take Highway 3 north to Silverdale, exit at Newberry Hill Rd, turn right. Follow Newberry Hill (becomes Silverdale Way) to Bucklin Hill, turn right. Go to Nelson Rd, turn right. At Fairgrounds road turn right, follow to show site.

**FROM BREMERTON FERRY** - Depart ferry onto Washington (becomes 11th), turn right on to Warren Ave, which becomes Wheaton Way. Stay on Wheaton Way thru East Bremerton to Fairgrounds Rd, turn left. Follow to fairgrounds & show site.

**FROM BAINBRIDGE FERRY** - Depart ferry through town, follow about 10 miles through Poulsbo to Highway 3. Follow signs south to Silverdale/Bremerton. At Silverdale, follow signs to East Bremerton via Waaga Way. Exit at Central Valley Rd. Follow to Fairgrounds Road, turn right. Follow to fairgrounds & show site.

**FROM KINGSTON FERRY** - Depart ferry south out of Kingston, follow Bond Rd to Highway 305 at Poulsbo. Turn right, follow signs south to Silverdale/Bremerton. At Silverdale, follow signs to East Bremerton via Waaga Way. Exit at Central Valley Rd. Follow to Fairgrounds Rd, turn right. Follow to fairgrounds & show site.

## **JUNIOR SHOWMANSHIP**

**NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

**NOTICE:** Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

**NOVICE AND OPEN CLASS DIVIDED:** Junior-9 years old & under 12 years old on the day of the show; Intermediate-12 years old & under 15 years old on the day of the show; Senior-15 years old & under 18 years old on the day of the show

**NOTE - SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S):** There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

## **SWEEPSTAKES**

Sweepstakes is open to all Cocker Spaniels that are six months of age 6 months & under 13 months of age on the day of the show. Dogs shown in sweepstakes must also be entered in one of the regular classes at the regular entry fee and on the regular entry form. Sweepstakes will be judged prior to regular classes. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class".

### **DIVISION OF SWEEPSTAKES ENTRY MONEY**

Entries will be taken the morning of the event only – No entry fee

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5-9 years of age. Safety is a primary concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- The dogs must be Cocker Spaniels.
- Bitches in season will not be allowed to participate.
- All dogs entered must have the proper lead & collar.
- Judging will be held during a break.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- There is no fee, but each parent/guardian must sign a waiver.
- Waivers/entry blanks will be available at the club table.

Because safety of both the dogs and Juniors is a primary concern an additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.
