NON-REGULAR CLASSES (INVOLVING SINGLE DOG ENTRIES)

Veteran Dogs (7 yrs. & under 9 yrs.)
Veteran Dogs (9 yrs. & under 11 yrs.)
Veteran Dogs (11 yrs. & older)

Veteran Bitches (7 yrs. & under 9 yrs.)
Veteran Bitches (9 yrs. & under 11 yrs.)
Veteran Bitches (11 yrs. & older)

Dogs/Bitches entered in Veterans Class need not be intact. Spayed & Neutered animals are eligible. Winners of the above classes, if otherwise undefeated, are eligible to compete for Best of Breed BEST OF BREED COMPETITION: The following categories of dogs may be entered and shown in Best of Breed Competition: Dogs that are Champions of Record and dogs that according to their owners records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owner's records.

BEST BRED-BY-EXHIBITOR (BBE): After Best of Breed, Selects, & Awards of Merit are chosen, the winners of Bred by Exhibitor Dog/Bitch classes, and any dog in the Best of Breed ring that has declared themselves eligible at the time of entry (including WD, WB, BOBs & Veterans), compete for Best Bred by Exhibitor. If Best of Breed is a declared eligible dog, that entry is automatically Best Bred by Exhibitor. Exhibitors MUST enter their chosen class, and also check the BBE Box on the entry blank to be eligible.

NON-REGULAR CLASSES (INVOLVING MULTIPLE DOG ENTRIES)

STUD DOG. For Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for the breed. Get must be entered in a regular class, Best of Breed competition or some other non-regular class.

BROOD BITCH. Same as Best Stud Dog except substitute Brood Bitch for Stud dog and Produce for Get.

NOTE: As the judge's decision in the Stud Dog or Brood Bitch Class is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.

SPECIAL RECOGNITION

AWARDS OF MERIT: All dogs presented in the Best of Breed Competition will be eligible for the CRC Judge's Award, excluding dogs already awarded BOB, BOS, SD, SB or BOW. The maximum number of CRC Judge's Awards that may be given will be 10% of the Best of Beed entry (standard rounding rules >-.5 round up, else round down.) These CRC Judge's Awards may be chosen by the Breed Judge and presented with no consideration to sex.

BEST PUPPY: After Best of Breed, Selects, & Awards of Merit are chosen, the winners of 6-9, 9-12, and Bred by Exhibitor Puppy classes compete for Best Puppy. If Best of Winners is from one of the 6-9, 9-12, or Bred by Exhibitor Puppy classes that entry is automatically Best Puppy.

BEST VETERAN: After Best of Breed, Selects, & Awards of Merit are chosen, the winners of various Veteran classes compete for Best Veteran. If Best of Breed is from one of the Veteran classes that entry is automatically Best Veteran.

BEST OF THE BEST

CONFORMATION - BEST OF BREED: The winner will be chosen by having the Best of Breed winners from Show #1, Show #2 and Show #3 compete against one another. One of these three will be Chosen as the Best of the Best.

OBEDIENCE: The winner will be chosen by having the High in Trial Winners from Each Day compete in a run off.

RALLY. The winner will be chosen as follows: Highest score with lowest time per class at each trial will do a run-off to determine the winner for each Trial. The winners from Trial #1, Trial #2, and Trial #3 compete in a run off.

AKC NATIONAL OWNER-HANDLED SERIES

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Professional handlers,* household members and current assistants to professional handlers** may not exhibit. Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- · No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.
- *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- **A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

JUNIOR SHOWMANSHIP COMPETITION

- **NOVICE CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.
- **OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.
- MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year. NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show.

She Changed many lives through her years of service visiting patients at hospitals, rehab centers, children's wards, psychiatric units and hospice. She even saved my mom's life by detecting her heart disease before she even knew what was wrong. Her instincts were spot on.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- · Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
