

## EXHIBITORS PLEASE NOTE CHANGE OF VENUE

Due to the Covid-19 vaccination clinic being held in Ellensburg at the Fairground, the Yakima Valley Kennel Club dog show for 2021 has been moved from Ellensburg, Washington, to the **Sozo Athletic Complex in Yakima, Washington**. The address is 2200 S 36th Ave, Yakima, WA 98903

You can find the map and aerial view of the site on *googlemaps.com*. **The show will be totally outdoors on a grass field.** Restrooms are next to the field. The field is very large and there is a very large asphalt parking lot next to the field.

**Day parking is \$5. There is no reserved grooming.** Exhibitors should expect that **there will be no power available**. Exhibitors may set up pop up tents in the field. Be forewarned, it can be very windy at this location and tents should be securely tied down.

### *The best route to the show from the north is as follows:*

Take exit 34 from I-82. This is the Nob Hill boulevard exit. Drive about 1 mile west to South 1st Street. Turn left onto South 1st Street and drive about 1 mile south to Washington Avenue. Turn right on Washington Ave and drive west about 4.2 miles. At about 3.9 miles, the road starts to bend to the left. Look for a sign that says S. 48th Avenue. It is a left turn off from Washington. Once on that street follow the signs to Sozo Athletic site. The show site is about 1 mile from where you exited Washington Avenue.

**There will not be any power for RV's or grooming.** If you have sent in reserved grooming forms and checks, we will be in contact with you to determine what you want us to do with your check. If you have already contacted us we will be following your directions.

There will be access to potable water at the restroom building. **NO DOG BATHING!!!** Bring containers for hauling your water as needed. **There are no showers** at this site.

We will be following Covid procedures even though this is an outdoor show. It is expected that the governor will make more changes between now and the show. You should expect to be temperature tested and you should expect to sign a Covid waiver form.

## ***COVID-19 EVENT PLAN***

---

The following plan will be enforced throughout all time relevant to the Yakima Valley Kennel Club, Inc., all-breed dog shows and the associated events (collectively referred to as "The Event"). This plan is subject to change as necessary.

1. IF YOU ARE ILL, COUGHING, SNEEZING, RUNNING A TEMPERATURE OR FEEL UNWELL, please stay home because any Spectator, Exhibitor or Attendee with these conditions will not be admitted to The Event.
2. EXPOSURE TO COVID-19: If you have recently tested positive for COVID-19, or if you have recently been in the presence of a person who has either tested positive for COVID-19 or has the symptoms of COVID-19 (including, but not limited to, coughing, sneezing, or high temperature), please stay home because any such by Spectator, Exhibitor or Attendee will not be admitted to The Event. If proof of a positive COVID-19 test dated from The Event closing dates through April 29, 2021, is submitted, you will be eligible for a partial refund of entry fees.
3. WRISTBANDS AND ADMISSION INTO THE EVENT: The following procedures will be in place throughout The Event:
  - a. Wrist Bands or Stickers: All Spectators, Exhibitors, and Attendees will be given a wrist band or sticker to indicate The Club has a signed Waiver on file. If you lose your wrist band/sticker or it falls off, please go to the COVID-19 Monitor at the entrance of the Umtanum Building, for another wrist band or sticker; it will be confirmed that a signed Waiver is on file before another wrist band or sticker will be issued. Please note you MUST have a wrist band or sticker to pick up any armbands; and
  - b. Failure to comply with these procedures will result in a bench hearing.
4. ATTENDANCE: All Exhibitors and Attendees must adhere to the Social Distancing Guidelines provided in Paragraph 5 below. This includes, but is not limited to, placing chairs six (6) feet apart or creating small "family units." Please understand that Exhibitors and Attendees may be asked to move, spread out, or wait outside the building, so that state, county, and/or local social distancing requirements may be maintained.
5. SOCIAL DISTANCING: All Exhibitors and Attendees must maintain social distancing of the recommended six (6) feet from others in attendance at The Event. Please be cognizant that other Exhibitors and Attendees may have medical issues or concerns of which you are unaware. Those in attendance at The Event will undoubtedly have different levels of concern and fear, and thus The Club is requiring that each individual in attendance at The Event to be respectful of others.
6. MASKS: PER AKC AND THE CLUB, EVERYONE IN ATTENDANCE AT THIS EVENT WILL BE REQUIRED TO WEAR A MASK AT ALL TIMES THAT ADEQUATELY COVERS BOTH THE NOSE AND MOUTH. YOU ARE REQUIRED TO SUPPLY YOUR OWN MASK(S). THERE WILL NOT BE ANY EXCEPTIONS.

7. DESIGNATED COVID-19 MONITORS: The Club will have assigned throughout the duration of The Event “COVID-19 Monitors” who will be responsible for the following:
- a. Ensuring that all Exhibitors and Attendees are in compliance with the mask-wearing requirement set forth in Paragraph 6 above;
  - b. Ensuring that all Exhibitors and Attendees are wearing a wrist band or sticker as provided to them to indicate that The Club has a signed Waiver on file for that individual; and
  - c. Providing the COVID-19 Event Waiver to those who need to execute it prior to entry into The Event facilities.
8. SANITIZING STATIONS: Sanitizing stations will be placed throughout The Event facilities which will include disinfecting wipes and/or hand sanitizer.
9. CRATING: Dogs may only be crated ringside 15 minutes prior to, and during judging.
10. ARM BANDS: You must know your arm band number and have a wrist band or sticker before picking up your arm band. A table will be provided, and the arm bands laid out in advance of each class. Remember to maintain social distancing guidelines while you are obtaining your arm bands.
11. ENTRANCE AND EXIT FROM THE EVENT FACILITIES:
- a. On the first day of the Exhibitor’s and Attendee’s attendance at The Event, it must be confirmed that all Exhibitors and Attendees to The Event have signed the “COVID-19 Event Waiver.” Entry will be denied to anyone refusing to sign the Waiver.
  - b. Once it has been confirmed that The Club has a signed waiver for the Exhibitor and/or Attendee, the Exhibitor and/or Attendee will be issued a wristband/sticker to wear for the duration of the event. If that wristband/sticker is lost or if it comes off, please return to the COVID-19 monitor to obtain another wristband.
12. HAND WASHING: As always, washing your hands frequently and thoroughly and not touching your face decrease the spread of germs. Continual hand washing throughout the day by Exhibitors and/or Attendees is encouraged. The restroom area will provide a wash station, hand sanitizer and paper towels for drying your hands. The Clubs also suggest that Exhibitors and/or Attendees keep a supply of sanitizing wipes and an alcohol-based hand sanitizer with them and use those items as necessary.
13. RING ENTRY/EXIT: The ring will have a separate entrance and exit, clearly marked. Markings will be placed to assist exhibitors with proper distancing while in the ring.

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record and dogs which according to their owner’s records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed champions in Best of Breed (Variety) Competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. Select Dog and Select Bitch, where applicable, will be chosen immediately following Best of Breed competition. This will be followed by Best Owner-Handled.

**Retrievers (Labrador):** Open Classes Divided, Both Sexes: Black; Chocolate; Yellow.

**Dachshunds (All Varieties):** Open Classes Divided, Both Sexes: Miniature (under 11 lbs. & 12 mos. old or older); Standard (11 lbs. & over and under 11 lbs. if less than 12 mos. old).

**Boxers:** Open Classes Divided, Both Sexes: Brindle; Fawn.

**Doberman Pinschers:** Open Classes Divided, Both Sexes: Black; Any Other Allowed Color.

**Great Danes:** Open Classes Divided, Both Sexes: Black; Blue; Brindle; Fawn; Harlequin; Mantle Merle

**St Bernards:** Open Classes Divided, Both Sexes: Longhaired; Shorthaired.

**Boston Terriers:** Open Classes Divided, Both Sexes: Under 15 lbs., 15 lbs. & Over.

**Australian Shepherds:** Open Classes Divided, Both Sexes: Black; Blue Merle; Red Merle; Red.

**Collies (Rough):** Open Classes Divided, Both Sexes: Blue Merle; Sable & White; Tri-Color; White.

**Shetland Sheepdogs:** Open Classes Divided, Both Sexes: Sable & White; Any Other Allowed Color.

## **JUNIOR SHOWMANSHIP COMPETITION**

---

**NOVICE CLASS:** This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

**OPEN CLASS:** For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

**MASTER CLASS:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

**NOVICE AND OPEN CLASS DIVIDED:** **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

**After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.**

**NOTICE:** Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

**NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S):** There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

### **USE OF RAMPS – ALL BREEDS**

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: Lagotto Romagnolo, Nova Scotia Duck Tolling Retrievers, American Water Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Grand Basset Griffon Vendéen, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs, and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels, Whippets, and Miniature Bull Terriers.

At the discretion of the judge through all levels of competition, the following breeds may be judged on a ramp, or on a table: Mudi.

The following breeds must be judged on a ramp through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirneco dell'Etnas, Bulldogs, Chinese Shar-Pei, Keeshonden, and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor may withdraw their entry and receive a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (01/2021)

- The American Kennel Club will collect: a \$3.00 Event Service Fee and \$.50 Recording Fee where applicable for the first entry of a dog, plus a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single-entry classes, in all AKC licensed and member club events. At every licensed or member club rally trial, a recording fee of \$3.50 is required for the first entry of each dog and a recording fee of \$3.00 is required for each additional entry of the same dog.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. Baray Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.

# AKC Code of Sportsmanship

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companionship. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

## **AKC NATIONAL OWNER-HANDLED SERIES**

---

*The purpose of the AKC National Owner-Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers and to provide a venue for the owner/handlers to compete against their peers. The determination of the awards in the AKC National Owner-Handled Series is based solely on the quality of the entry. The owner/handler's handling ability is not of consideration.*

- Dog must be marked as eligible to compete in the AKC NOHS prior to the closing of entries. There is no additional fee to enter this competition.
- Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Additionally, dogs must be handled by an eligible owner/handler for all AKC National Owner-Handled Series competition (Group and Best in Show). Any person may exhibit the dog in the regular Group and Best in Show competitions.
- Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form. The handler must be an owner of record according to the AKC's records as of the date of the show. Dogs declared eligible will be identified by an asterisk or other representative mark in the judge's book, steward's book, and the show catalog.
- \*Professional handlers, household members and current assistants to professional handlers may not exhibit.
- The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

*\*Professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Eligibility restrictions apply to all members of the same household. Household members and current assistants to professional handlers in conformation are not eligible to exhibit in this competition. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

## **SANCTIONED FOUR-TO-SIX MONTH BEGINNER PUPPY – SATURDAY**

**Entries Close Wednesday, 12:00 Noon, April 14, 2021, at Superintendent's Office**

**Section 1- Classifications** – The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

**Section 2 – Entry and Eligibility** – Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate.
