NOTICE TO EXHIBITORS – ALL EVENTS

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The American Kennel Club will collect the following at every Licensed or Member club event: An AKC

Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

Winners of the above Non-Regular Classes, if otherwise undefeated, compete for Best of Breed.

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed (Variety) Competition: Dogs that are Champions of Record; and Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owners' records. If at the end of the 90 day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

SELECT DOG AND BITCH • NOHS BEST OF BREED • AWARD OF MERIT

BEST PUPPY • BEST VETERAN – BEST BRED BY EXHIBITOR (Overall)

SPECIAL RECOGNITION

AWARDS OF MERIT: The maximum number of Awards of Merit that may be presented is determined by calculating 10% of the combined entries in Best of Breed, Winner's Dog, Winner's Bitch, and the non-regular classes involving single-dog entries, with any fractional result rounded up to the next whole number. At the conclusion of Best of Breed judging, the specialty judge may, at his or her discretion, recall eligible dogs into the ring and award up to the maximum number of Awards of Merit calculated above. All dogs from the classes included in the calculation are eligible for an Award of Merit except Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch, and Best of Winners, as those dogs are considered worthy of merit by virtue of their wins.

BEST PUPPY IN SPECIALTY:

At the conclusion of the Best of Breed judging, the specialty judge will choose their Best from all the winners of the Puppy Classes including the BBE Puppy Classes. If Best of Winners is from a puppy class, they automatically are awarded Best Puppy.

BEST VETERAN IN SPECIALTY:

At the conclusion of the Best of Breed judging, the specialty judge will choose their Best from all the winners of the Veteran Classes. If Best of Breed is from the Veteran Class, they automatically are awarded Best Veteran. If Opposite is a Veteran, only the other gender of dogs return to the ring for consideration.

DRIVING DIRECTIONS

US-2 FROM LEAVENWORTH: Head East on US-2 about 10 miles to the Hay Canyon signal and turn left. At the traffic circle take the third exit and go over the bridge to Sunset Highway in about 0.4 miles and turn right. In about 0.4 mile turn left on Westcott Drive. Follow dog show signs.

US-2 FROM WENATCHEE: Take US-2 W/US-97 S Approx. 10 miles to the Hay Canyon signal and turn right. At the traffic circle take the third exit and go over the bridge to Sunset Highway in about 0.4 miles and turn right. In about 0.4 mile turn left on Westcott Drive. Follow dog show signs.

I-90 EASTBOUND FROM SNOQUALMIE PASS: Take exit 85 for WA-970 N toward Wenatchee. Turn left toward WA-10/WA-970. Turn right onto WA-10/WA-970. Continue to follow WA-970 for 9.9 miles. Continue straight onto US-97 N for 35.1 miles. Slight right to merge onto US-2 E/US-97 N toward Wenatchee. Head East on US-2 about 5 miles. Head East on US-2 about 5 miles to the Hay Canyon signal and turn left. At the traffic circle take the third exit and go over the bridge to Sunset Highway in about 0.4 miles and turn right. In about 0.4 mile turn left on Westcott Drive. Follow dog show signs.

Eligible dogs will be identified by an indicator in the steward's book & the catalog. Exhibitors must declare their dog is Bred By Exhibitor eligible at the time of entry and must be handled throughout the breed level competition by an eligible breeder owner. Best of Breed Bred By Exhibitor will be selected from the dogs that are competing in Best of Breed competition. **Remember to check the box near the top of the entry form.**
