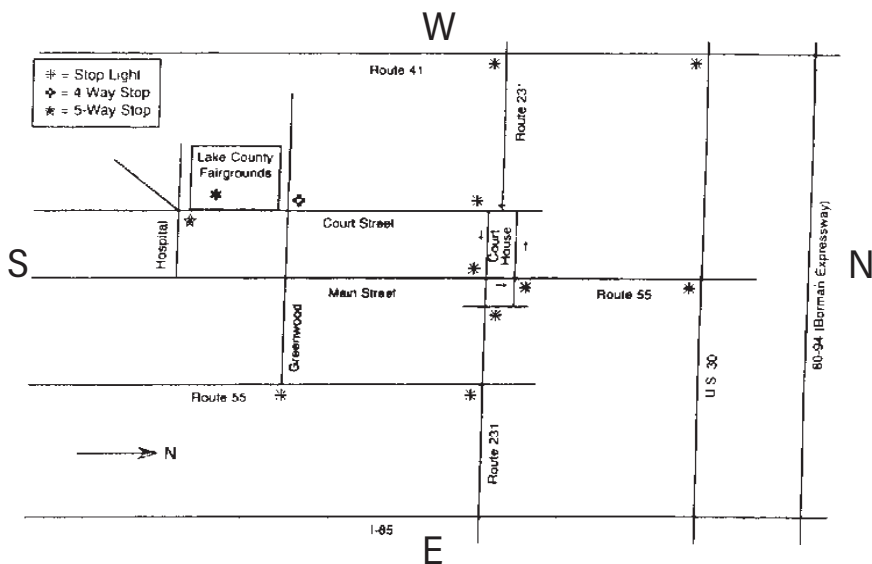

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN Class divided: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

RESERVE JUNIOR HANDLER: After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

NOTICE TO EXHIBITORS

- CONFORMATION, OBEDIENCE & JUNIOR SHOWMANSHIP ENTRANTS: BUILDING WILL BE AVAILABLE THURSDAY AFTERNOON FROM 3:00PM UNTIL 9:00PM. The above provisions for leaving dogs in the Lake County Fairgrounds overnight is a provision of the Clubs for the convenience of the exhibitors. The Club, their members, directors, officers, agents, show superintendent, and the said employees of the said kennel club and/or its superintendents will not be liable for any loss or injury which may be sustained through the loss, theft, injury and/or death of dogs entered in this event whether said loss, theft, injury and/or death is or are caused by the negligence or carelessness of the said Kennel Clubs, their members, directors, officers, agents, superintendents, and/or employees of the said Kennel Clubs and/or employees of their superintendents or by negligence of any person or any other cause.
- NO DOGS ARE ALLOWED IN THE RESTROOMS OR OTHER DESIGNATED AREAS.
- DOGS MUST BE ON A LEASH or confined to their crates except when being judged or in the exercise pens provided.
- THE LAKE COUNTY FAIRGROUNDS will be available on Friday and Saturday nights for exhibitors who wish to leave their dogs in the building overnight. The building will be locked promptly at 9:00PM each night and will not reopen until 6:30AM the following morning.
- PARKING IS FREE.
- NO MESH CRATES ALLOWED IN THE BUILDING.
- BUILDING & RESTROOMS ARE HANDICAPPED ACCESSIBLE.
- HANDICAP PARKING – Limited handicap parking is available.
- NO PARKING OR BLOCKING OF ANY ENTRANCE OR EXIT OF ANY BUILDING EXCEPT FOR LOADING OR UNLOADING. AFTER UNLOADING, VEHICLES MUST BE MOVED AS QUICKLY AS POSSIBLE. Vehicles left in the unloading area more than 30 minutes with no activity will be ticketed or towed without further announcement. Note: Towing charges are approximately \$100.00. All parking is at the discretion of the Club. Overnight parking will be in designated spaces only. (See next page for reservation form). Failure to comply with these rules may result in an Event Committee hearing. The saving of space will be on a limited basis only and at the total discretion of the Club.
- RV PARKING Ample in Designated Areas – No RV parking on the south side of the main area or on the public streets outside of the Fairgrounds.
- MUST TURN OFF CELL PHONES and/or PAGERS BEFORE ENTERING RINGS.
- No puppies under 6 mos. of age will be allowed on the show grounds during show hours, except for entrants into the 4-6 Month Beginner Puppy.
- UNENTERED DOGS ARE NOT ALLOWED ON THE SHOW GROUNDS.
- CLEAN UP NOTICE: Exhibitors/Handlers will be held responsible for keeping their grooming & crating areas clean. Failure to do so may result in disciplinary action. All litter must be placed in containers that are provided on the grounds and in the buildings.
- EXHIBITORS MUST CLEAN UP AFTER THEIR OWN DOGS IN ALL GRASS AND PAVED AREAS OF THE FAIRGROUNDS. For the convenience of the exhibitors and their dogs, exercise pens will be available for the animal's toiletry needs. PLEASE EXERCISE DOGS BEFORE ENTERING THE SHOW RING.
- Electricity is provided on a limited basis AND IT IS EXPECTED THAT IT WILL BE SHARED.
- NO STROLLERS WILL BE ALLOWED IN THE EXPOSITION BUILDINGS. The welfare of a child is assumed to be the responsibility of the adult bringing the child to the show. It is distinctly understood that adults will exercise control and restraint over their children at all times.
- NO SMOKING IN BUILDING AT ANY TIME.
- NO ALCOHOLIC BEVERAGES. Lake County Fairgrounds prohibits any alcoholic beverages to be carried in.
- No cutting of rope or tape or removal of any barricade.
- No grooming or crates allowed at ringside. Show & Go crates will be allowed at ringside in designated areas during that breeds' judging at the discretion of the Show committee.
- NO CONES TO SAVE SPACES ALLOWED IN SOUTH LOT.
- Due to a change in LCFG policy no ring matting is allowed in the 4H Building. Therefore all rings will be in buildings without Air Conditioning. The 4H Building will be available for cooling area during show hours.
- Any crates left in areas marked: SHOW AND GO will be removed during Group Judging.

**** 2026 Reserved Overnight Parking ****

At Lake County Fairgrounds, Crown Point, IN
June 18, 2026 (Thurs) thru June 21, 2026(Sun.)

- ALL RV and overnight parking is by reservation only and in designated areas. Space is limited. Spaces Assigned by Club.
- By local ordinance, the fairgrounds gates are closed at 9:00PM each evening and reopen at approx. 6:30AM. No RVs will be admitted on Thursday, Friday or Saturday evening after the fairgrounds is closed. No exceptions are made under Fairgrounds rules. Emergency exit instructions will be provided to those in place by 9:00PM each evening.
- Reservations are on a first come, first served basis within the grounds; no specific space is reserved for any party.
- Reservations must indicate and pay for electrical to have access to electrical hookups! If you pay for a space without electrical, you will not be permitted to plug into the Fairground electrical hookups. Electrical hookups are only permitted in designated spaces. Limit two plug-ins per space where electrical has been paid for. Very limited electrical hookup spaces available.
- ONLY 15 Amp max service available. Overtaxed service may blow fuses and fairground reset is not available overnight. NO REFUNDS FOR BLOWN FUSES DUE TO OVERTAXING AMPERAGE.
- The Lake County Fairgrounds is not a camping fairgrounds. No gray dump or water hookups available. No dumping on grounds of facility. Violators will be subject to disciplinary action.
- NO HANDICAPPED RV PARKING IS AVAILABLE as the parking lot is not set up for RV camping and RV parking for the show is an exception provided by the Fairgrounds.

Not reading the Premium List for these shows is no excuse for failure to follow or being unfamiliar with the rules and regulations of the American Kennel Club. No Arguments - No Excuses.

AKC SANCTIONED 4-6 MONTHS PUPPY - GROUPS OR ALL-BREED

Entries will close Wednesday Noon, June 3, 2026 at Superintendent's office.

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E."
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

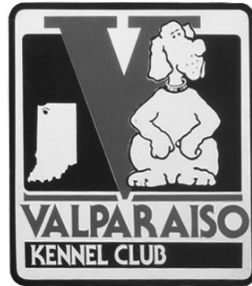

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The

American Kennel Club will collect the following at every Licensed or Member club event: An AKC Recording and Service Fee of \$4.50 for each entry. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent.
