NOTICE TO EXHIBITORS - ALL EVENTS

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The

American Kennel Club will collect the following at every Licensed or Member club event: An AKC Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES - Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE - The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS - By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

In the event of cancellation prior to entry closing, any entries submitted will be refunded minus the \$5.00 processing fee charged by BaRay. In the event of cancellation for any reason after entry closing, entries submitted will be refunded minus processing expenses (last shows were approx. \$11.00).

ATTENTION - SHOW GROUND RULES

- **NEW:** Absolutely nothing is allowed to go down storm drains (other than natural rain water) Anyone found in violation of this rule is subject to \$10,000.00 fine by the Department of Ecology and a \$500.00 fine by the Washington State Fair.
- **In the RV Lot** The appropriate sewer hookup or dump station should be used for depositing all gray (and black) water. Security will enforce the "no dumping" rule.
There is a \$500.00 fine for all/ any infractions of this policy.
- Golf cars available for transport (Fri/Sat/Sun) Look for signs and times at stop locations From Green Gate to Green Lot / Orange RV Lot Cart stops and inside show grounds.
- The Fairgrounds Will Be Open For Grooming Setup Thursday July 2nd from 11:00AM-6:00PM. The Puyallup Valley Dog Fanciers Show Committee recommends Exhibitors who have inside grooming set up on Thursday. Fri, Sat and Sun load/unload will only be available from 6:00AM-7:30AM (last car in the gate at 7:15AM) and again for 30 minutes after BIS. Golf Carts will be available to transport exhibitors during the day.
- **CONTROL OF THE GROOMING AND CRATING AREAS WILL BE THE RESPONSIBILITY OF THE GROOMING CHAIRMAN.** Grooming Chairman reserves the right to rearrange crates etc., in the non-reserved grooming area to make more room. Grooming equipment left in day grooming area after Best in Show will be confiscated. Grooming and Crating area aisles must remain open at all times.
- **Personal exercise pens, Cocker pens, Toy pens and/or canopies not allowed inside buildings during show.**
- Crates are only allowed in the 4H-Arena during the showing of your breed and must be removed immediately after. *Violators will be fined \$25.00 per occurrence.*
- Grounds will be open at 6:00 AM Friday/Saturday/Sunday July 3,4,5, and **close 90 minutes after Best in Show each day**
- Reserved Overnight Parking available until 10:00 AM on Monday (See RV Parking Signup).
- **No unauthorized parking on the Fairgrounds. Violators will pay a fine of \$50.00. Failure to comply risks a hearing by the show committee.**
- Loss or Damage - The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows.
- The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor/Parent. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the shows **OR THE EXHIBITOR/PARENT WILL BE ASKED TO LEAVE THE SHOW PREMISES.**
- The only fresh water available on the grounds will be in the restrooms (The restrooms or hand wash stations are the only place exhibitors may dump water of any kind). Exhibitors are responsible for the water required for the safety and comfort of their dogs.
- There is **NO INSIDE PARKING** available at the show. All parking is within proximity to all buildings inside the Green Gate. Disabled parking next to Green Gate please have DA placards on your dash.
- Exhibitors and Handlers will be held responsible for clean conditions in and around their grooming area, parking area and hotel room.
- **Exhibitors are responsible for their dogs. X-Pens are available. No dogs eliminating on Grass or flower beds or buildings, exhibitors risk a \$50.00 fine and/or hearing with show committee.**
- Speed limit within the Green Gate is 5MPH. Anyone exceeding the speed limit will be subject to an event show hearing, and/or escorted off the grounds immediately.
- **If it is necessary to rescue a dog from a parked vehicle on the show grounds or in the parking areas, the club will not be responsible or liable for any damage to the vehicle involved.** Animals left in vehicles will be monitored. If animals are in distress due to heat or any other circumstances, the vehicle will be forcibly entered, the animal recovered and the owner cited.
- No Smoking allowed or tolerated in any building on the Show Site. Offenders of the rule shall be subject to a fine not to exceed \$50.00, and in the event of continued abuse, shall be asked to leave the show premises.
- **TROPHIES** - Trophies and prizes will be awarded in the judging rings to the person exhibiting the dog, who will be considered to be the owner or agent of the owner. All claims for trophies and other prizes must be made in the judging ring before the completion of the judging of the breed, and the Show Chairmen advised at once of any discrepancy. No Award will be mailed. The Club reserves the right to substitute a prize of equal or greater value.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

REGISTRATION WILL BE TAKEN AT THE CLUB TABLE EACH MORNING FOR ITTY BITTY AND PEE WEE SPECIAL ATTRACTIONS, STARTING AT 9:00AM. EACH ENTRANT WILL BE REQUIRED TO FILL OUT AN ENTRY FORM. IN ADDITION TO AN ENTRY, A RELEASE MUST BE SIGNED BY THE CHILD'S PARENT OR LEGAL GUARDIAN. JUDGING WILL BE HELD DURING THE LUNCH BREAK. NO ENTRY FEE. ALL PEE-WEE PARTICIPANTS WILL RECEIVE A RAINBOW ROSETTE.

ALL DAYS - ENTRY FEE: \$25.00

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Entry and Eligibility

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: **Junior**-9 years old and under 12 years old on the day of the show; **Intermediate**-12 years old and under 15 years old on the day of the show; **Senior**-15 years old and under 18 years old on the day of the show.

RESERVE JUNIOR HANDLER: After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

USE OF RAMPS – ALL BREEDS

The following breeds **must be judged on a ramp** through all levels of conformation competition: Lagotto Romagnolo, Clumber Spaniels, English Springer Spaniels, Sussex Spaniels, Basset Hounds, Cirneco dell'Etnas, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden and Spanish Water Dog. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. The full policy and list of Table and Ramp eligible/required breeds is available on the AKC website at: https://images.akc.org/pdf/judges/table_breeds.pdf

Ramps can be used to judge any breed in an emergency situation where use of a ramp is not indicated in the premium list; an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds. (01/2026)

- 4H Bldg. A & B Ground Floor and Draft Barn (Stalls) D and Horse Barn (Stalls) C for 2026.
- Requests for specific spaces or buildings will be considered; however, they cannot be guaranteed.
- Grooming buildings available for set-up THURSDAY July 2 11:00AM-6:00PM. Do not try to access Grooming buildings before this time.

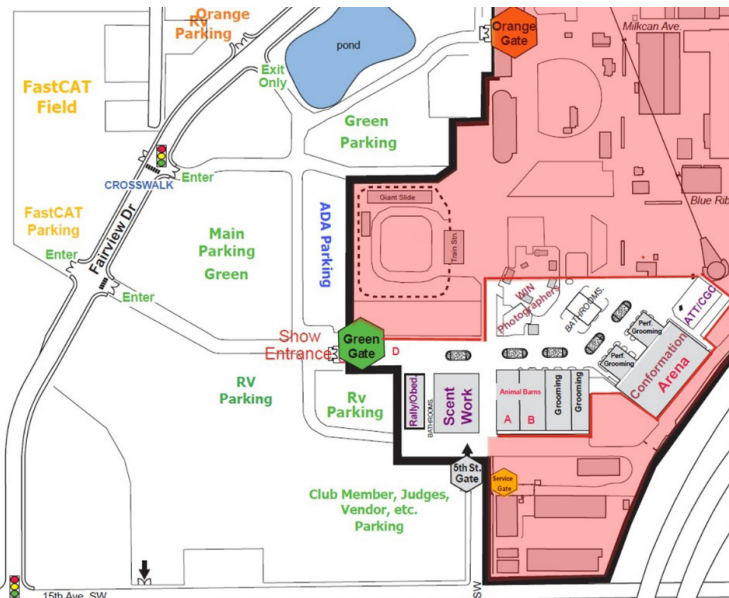

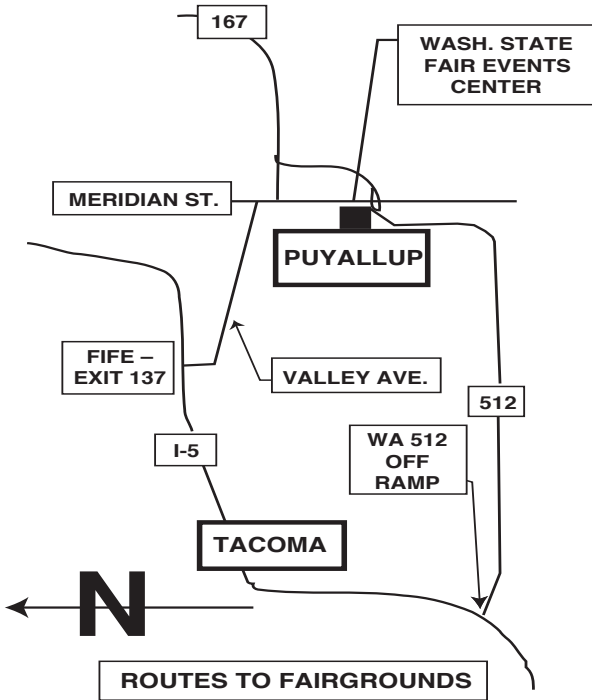

FROM OLYMPIA AND THE SOUTH: Take I-5 North to Hwy. 512, Exit 127. Follow Hwy. 512 east for 10 miles to the Meridian St., S. Exit. Turn left under the freeway. Fairgrounds are on the left.

FROM SEATTLE AND THE NORTH: Take I-5 South to the Puyallup Exit #142B in Federal Way. As exiting, stay in the left lane. Turn right at the traffic light at the end of the exit ramp, then turn left at the first traffic light onto Hwy. 161. Travel approximately eight miles into the Puyallup Valley (Hwy. 161 becomes Meridian St. in Puyallup). Continue south through town. The Fairgrounds will be on your right at 9th Ave. S.W.

FROM BELLEVUE AND THE EASTSIDE: Take I-90 to I-405 S. Take Exit 2 to Hwy. 167 toward Kent/Auburn. Travel South on Hwy. 167 for approx. 20.2 miles to Hwy. 161 South/Hwy. 512 W. Travel 2.3 miles to the second exit, Meridian St. S. At the light at the end of the exit turn right. Fairgrounds are on the left.

FROM SEATAC AIRPORT:

Option 1: Depart airport, taking exit to I-5 and I-405. Follow signs to I-405 Northbound toward Renton and Bellevue. Take Exit 2, Hwy. 167 South toward Kent/Auburn. Travel south on Hwy. 167 for 20.2 miles to 161 South/512 West. Follow Hwy. 512 West to Puyallup and Olympia, traveling 2.3 miles. Take the second exit, Meridian Street South. Turn right at the light at the end of the exit. The fairgrounds are on the left, on the corner of Ninth and Meridian (Cattin's Restaurant is on the corner).

Option 2: Take I-5 south to the Puyallup Exit #142B in Federal Way. As exiting, stay in the left lane. Preface: The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.
