NOTICE TO EXHIBITORS – ALL EVENTS

The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List. The American Kennel Club will collect the following at every Licensed or Member club event: An AKC

Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

Veteran Class entrants need not be intact. Spayed or neutered dogs/bitches are eligible. Winners of the Veterans Classes, if otherwise undefeated at this show, are eligible to compete for Best of Breed.

BEST OF BREED COMPETITION

SELECT DOG SELECT BITCH

Selected immediately following Best of Breed: Select Dog/BitCh, Awards of Merit, followed by Best Puppy, NOHS Best of Breed, Best Bred by Exhibitor, Best Stud Dog/Brood Bitch, Best Veteran, and Best Brace (See page 5).

The following categories of dogs may be entered and shown in Best of Breed or Variety competition: Dogs that are Champions of Record, or Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where a dog completed the requirements for a championship according to the owners' records. Winners of the above Non-Regular Classes may also compete in the Best of Breed Competition, provided that they are undefeated in any Regular Class at this show.

OWNER-HANDLED BEST OF BREED

This event qualifies for the AKC National Owner-Handled Series. Exhibitor MUST check the Owner-Handled checkbox on the entry form to be eligible.

Non-Regular Classes (Involving Multiple Dog Entries) - Show #1 Only

Note: Non-regular classes involving multiple entries may be judged before or after Best of Breed. As the judge's decision in these classes will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed or Best of Opposite Sex to Best of Breed by virtue of having won the class.

Stud Dog Class and Brood Bitch Class: Each entry is allowed two and not more than four get unless otherwise specified. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get must be entered in a regular class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get being exhibited, must wear armbands. Ch. 11, Sec. 8 of the "Rules Applying to Dog Shows" provides that "a castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class."

Brace Class: Two Dogs, performing in unison, and presented by a maximum of two handlers. Both dogs competing in the brace class must have at least one common owner. Dogs do not need to be entered in any other class. Dogs comprising a Brace Class must be named at the time of entry, and full particulars must be given for each dog on individual entry forms. If a dog which is to be part of a Brace is not entered in another class, it must be entered for "Brace Class only." An entry form for a dog entered in another class and entered as part of a Brace must be marked accordingly in the space provided for additional classes as "Brace Class."

AKC SANCTIONED 4-6 MONTHS PUPPY

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if it is registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. Entries must be marked "Exhibition Only" prior to the close of entries. Exhibition-only entrants will participate in the same BPUP classes as regular entries. Judges will evaluate exhibition-only entrants in the same manner as regular entrants but will not consider them for awards. All Exhibition BPUP entries will receive an armband/catalog number starting with a capital "E"
- To be competitive, dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

SPECIAL RECOGNITION

Awards of Merit - After awarding Best of Breed, the judge may award up to three (3) Awards of Merit based solely at judge's discretion. Awards of Merit are offered at both shows.

Best Bred-by Exhibitor, Best Puppy, Best Veteran (Show 1 only) - Eligibility for Best Bred-by Exhibitor, Best Puppy, Best Veteran competitions is predicated upon entry into the following class(es) and all divisions of:

- **Best Bred-By Exhibitor** - the Bred-by-Exhibitor class including the Bred-by-Exhibitor Puppy and Bred-by-Exhibitor Adult age divisions
- **Best Puppy** - any class limited to dogs six months and older and under 12 months of age; 6-9 Puppy, 9-12 Puppy, and Bred-by-Exhibitor Puppy
- **Best Veteran** - any non-regular Veteran Class

For Best Bred-By Exhibitor, the eligibility criteria involving the individual handling the dog applies only to the original class entered and all competition specific to the special attraction (i.e., BBE Groups and BBE BIS). There are no restrictions as to who may handle the dog in any subsequent classes it may become eligible.

NOTE: Best Veteran, Best Puppy or Best Bred By Exhibitor competition will be forgone if the Best of Breed is one of the above.

Best Stud Dog /Brood Bitch (Show #1 only)- Chosen from the winners of the Stud Dog and Brood Bitch Classes.

Best Brace (Show #1 only) - Two Dogs, performing in unison, and presented by a maximum of two (2) handlers. Both dogs competing in the brace class must have at least one (1) common owner.

SWEEPSTAKES - SHOW #1 ONLY

The Sweepstakes is open to all Boston Terriers who are 6 months & under 18 months of age on the day of the show. Champions of Record are NOT eligible for Sweepstakes. Only Professional Handlers who are owners of record may handle dogs in Sweepstakes. All dogs entered in Sweepstakes must also be entered in a Regular Class. Sweepstakes will be judged prior to the Regular Classes. Indicate Sweepstakes and age division on the regular entry form under "Additional Classes." Entry fee is \$20.00.

Challenge Trophies



Memorial Challenge Trophy for Best of Breed. The Sierra Gold Boston Terrier Club will offer this memorial challenge trophy at each of its Specialty Shows. This Best of Breed Memorial Trophy is presented in loving memory of GCHS Campbell Clan's Bad Reputation BCAT CAX CGCA ROM (Rebel). The trophy was originally donated by her owners Dolores Ferrero and John W. Flora, Delphi Boston Terriers. The trophy was retired in April 2022 and donated back by Loretta Dolan, Loreda Boston Terriers. The Best of Breed winner's name will be engraved on the trophy, and the winner will receive a commemorative plaque celebrating their breed win. The trophy is to remain in the possession of the Club until such time that it is retired. To become retired, the Best of Breed Award must be won three (3) times by the same primary owner*, not necessarily with the same dog nor at

consecutive specialty shows.

Memorial Challenge Trophy For Best Veteran. The Sierra Gold Boston Terrier Club will offer this memorial challenge trophy during the first Specialty show. This Best Veteran Challenge memorial trophy will be presented in loving memory of CH Cool Maximum Impression aka "Max", originally donated by his owner, Lynda Bradley, Avalon Boston Terriers. - No mats to be used on the lawn area between the entrance and the concrete bollards (the area between Madden and Denverton Halls)
- Per the Fairgrounds: The use of stakes on the fairgrounds is restricted. It is suggested that exhibitors plan to use weights instead of stakes. Please let the Show Committee know if you should need help with transporting your equipment.
