## **NOTICE TO EXHIBITORS – ALL EVENTS**



**The American Kennel Club Rules and Regulations will govern this Show and Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.** The American Kennel Club will collect the following at every Licensed or Member club event: An AKC Recording and Service Fee of \$4.50 for each entry. An AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any 4 & Under 6 Months Puppy and Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes, or Special Attractions.)

- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, e-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on reverse side are NOT ACCEPTABLE. The Club and/or Baray Events assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **RESPONSIBILITY FOR COMPLETENESS OF ENTRY RESTS SOLELY WITH ENTRANT.**
- RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. BaRay Events will add a \$30.00 collection fee to the amount of each returned check. We will not re-process checks. The exhibitor will be contacted & required to send a money order for the original amount PLUS the \$30.00 NSF fee. Subsequent returned checks from same person may result in their being put on a CASH ONLY BASIS.
- REFUNDS for cancellations due to judge change or cancellations made prior to entries closing will be mailed by the Club to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.
- Females in season are not permitted to compete in Obedience or Rally Trials. If a female is withdrawn from competition because it came into season and the Superintendent is notified no later than one half hour prior to the start of the first class in the trial, the Club is required to refund the entry fee. The Clubs may retain a processing fee and must publish this information in the premium. Clubs may determine the documentation, if any that is required to confirm the female is in season. This shall be stated in the premium. Note: No fee is paid to the AKC for females in season who are withdrawn.
- FAX ENTRIES – Fax entries will not be accepted.
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund for DUPLICATE ENTRIES or OVERPAYMENTS. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show NO REFUND will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline 877-252-3229.
- Please note: Any hotel or motel listed in the premium list is subject to Event Committee Rules. We expect our exhibitors to be responsible guests. A report that an exhibitor at this show has abused hotel or motel property during this weekend may result in disciplinary action. Clubs reserve the right to decline future entries from the offending party in accordance with the provisions of Ch. 11, Sec. 15 of the Rules Applying to Dog Shows.
- Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the rings.
- Only dogs eligible for these shows will be admitted into show area. There is no provision for unentered dogs.
- LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, clubs should include any specific local health requirements; for example proof of rabies vaccination.
- PUBLICATION RIGHTS – By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

### Non-Regular Classes (Involving Multiple Dog Entries)

**Stud Dog Class and Brood Bitch Class:** Each entry is allowed two get/produce. The merits of the Stud Dog or Brood Bitch are not considered in the placement of the entry. It is the quality of the get that forms the basis for the judge's decision. All get/produce must be examined and gaited. The Stud Dog or Brood Bitch must also be examined to determine if there is a condition that would require disqualification or excusal under the Rules, AKC policy or the breed standard. All get/produce must be entered in another class in order to be eligible to compete in the Stud Dog or Brood Bitch Class. Handlers of the Stud Dog or Brood Bitch, and all get/produce being exhibited, must wear armbands.

Indicate Sweepstakes and age division on the regular entry form under "Additional Classes."

## **VETERAN SWEEPSTAKES**

Open to all Boston Terriers 7 years old & older. Dogs entered in Veteran Sweepstakes need not be eligible for regular veterans class, nor do they have to be entered in any other class. These older Bostons must walk with dignity, but their sight need not be perfect (presence of cataracts is allowed). They may be spayed or neutered and teeth may be missing. Can be handled in the ring by any person in good standing with the American Kennel Club. Mark "Veterans Sweepstakes AND age division" on the entry form. Veteran Sweepstakes will be judged prior to the regular classes.

## **SPECIAL RECOGNITION**

---

**AWARDS OF MERIT** - At the Boston Terrier Club of Portland, Oregon Specialty Show the judge, after awarding Best of Breed, Best of Winners, Best of Opposite Sex, Select Dog, and Select Bitch, may at his/her discretion, award one award of Merit for every 5 dogs entered for Best of Breed Competition.

**BEST BRED-BY EXHIBITOR** - Eligibility for Best Bred-by Exhibitor competition is predicated upon entry into the following class(es) and all divisions of Best Bred-By Exhibitor including the Bred-by-Exhibitor Puppy and Bred-by-Exhibitor Adult age divisions.

The eligibility criteria involving the individual handling the dog applies only to the original class entered and all competition specific to the special attraction. There are no restrictions as to who may handle the dog in any subsequent classes it may become eligible.

NOTE: Best Bred By Exhibitor competition will be forgone if the Best of Breed is from the above.



**FROM THE NORTH** - Take Exit 258 from I-5. Turn right onto Portland Rd NE and go 1.3 miles. Turn left on Lana Ave NE. Go 0.3 mi and turn right onto Silverton Rd NE. Go 0.4 mi. and turn left onto 17th St NE (at the light). RVs turn left at White Gate. Day parking is in the gravel parking lot to the right.

**FROM THE SOUTH** - Take Exit 256 (Market St) from I-5. Turn left onto Market St NE and go 0.7 mi. Turn right onto Evergreen Ave NE. Go 0.3 mi and turn onto Sunnyview Rd NE at the stop sign. Go 0.4 mi and turn right at the light onto 17th St NE. RVs turn right at White Gate. Day parking is in the gravel parking lot to the left.

**FROM THE WEST** - Take Hwy 26 into Salem and go over the bridge into downtown on Center St NE. Go 0.7 mi and turn left onto Capitol St NE. Go 1.2 miles and turn right onto Sunnyview Rd NE (stop light). Go 0.4 mi and turn left onto 17th St NE (stop light). RVs turn right at White Gate. Day parking is in the gravel parking lot to the left.
